

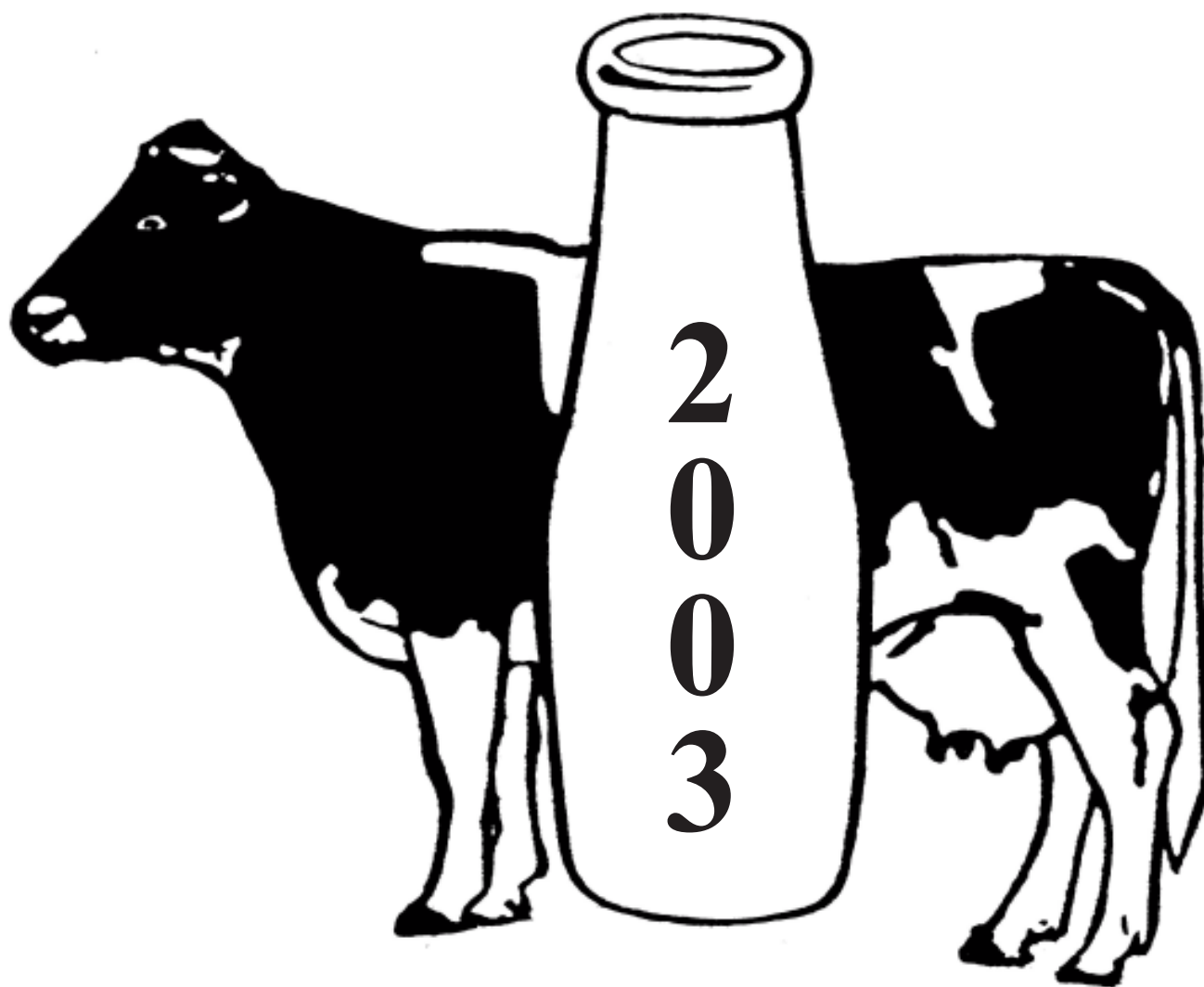

Summary

This bulletin provides information about the operation of the Northeast Order during 2003. The series of tables gives statistical data; some of the data is displayed graphically in figures. The *Bulletin* Highlights section summarizes, on a monthly basis, important events that impacted the dairy industry in 2003. This bulletin also includes lists of handlers and cooperatives operating under the Order.

Producer Milk Receipts

The volume of milk received from producers shipping to handlers regulated under the Northeast Order totaled 24.0 billion pounds, a decrease of 5.2 percent from last year. Production in many of the nation's top-producing states declined about mid-year. The Northeast Order's main contributing states (New York, Pennsylvania, and Vermont) finished 2003 with declines of 0.6, 1.7, and 3.2 percent, respectively.

The average number of producers pooled by handlers regulated under the Order equaled 16,114 in 2003, a decline of 4.5 percent. This was a greater decline than during 2002 when the average number of producers dropped 1.7 percent from 2001. The year finished with 743 producers fewer than at the end of 2002, which was down 376 from the previous year. The change in the number of producers is a combination of producer exits and pooling changes between orders.

During 2003, the annual average daily deliveries per producer (DDP) averaged 4,087 pounds, a decline of 0.7 percent from 2002. This was the first decline since the inception of the Northeast Order.

Class Utilization Changes

Class I utilization averaged 44.5 percent in 2003, an increase of 2.3 percentage points from the previous year. The total volume of milk used in Class I increased only 0.1 percent, but because of a smaller volume of producer milk receipts, the utilization percentage increased. Class I sales declined during 2003 in total and on a per capita basis.

Class II usage increased 1.3 percent resulting in a utilization increase of 1.2 percentage points. Class III volume declined 12.9 percent, with a corresponding utilization drop of 2.5 percentage points. Milk used in Class IV dropped 15.5 percent on a volume basis, but due to the smaller overall volume of producer milk, utilization declined only 1 percentage point.

Prices Mixed, but Overall Higher

National milk production was on the rise during the first quarter of 2003. During the remaining months, production declined or was nearly unchanged from the previous year for each corresponding month. This tightness in milk was reflected in higher commodity prices for cheese and butter, which are incorporated into the federal order price formulas. In addition, class price formulas were revised effective April 2003.

The Class I price was lower during the first 7 months of 2003 than during the same period the previous year. For the last 5 months, the Class I price was higher. The increase was a reflection of the tightness in milk, yet somewhat delayed due to advance pricing for Class I milk. Class III prices followed a similar pattern with the increase coming a month sooner due to the method of calculation that allows for a more timely change. Both Class II and IV prices were below the previous year's for nearly the entire year.

Overall, the statistical uniform price (SUP) reported at Suffolk County, Massachusetts (Boston), averaged \$12.99 per hundredweight in 2003. This was up 2.8 percent from the previous year. The Class I price increased 2.7 percent from 2002, while the Class III price averaged 9.6 percent higher. The Class II price was 6.8 percent lower than the previous year, and the Class IV annual average price was down 7.5 percent. Unlike previous years, the Class IV price was not the dominant mover of Class I prices. Due to the price formula changes, the Class III price began exceeding the Class IV price in July and continued throughout the rest of 2003.

Significant rapid increases in dairy commodity values during August caused a price inversion where the Class III price exceeded the SUP. As a result, for the first time since the Northeast Order's inception, the producer price differential was a negative value in all differential zones during the month of August. The highest SUP during the year was \$15.21 in October; the lowest was \$11.43 in March.

Milk Income Loss Contract (MILC) payments were paid from January through August as the Class I price was below the \$16.94 per hundredweight trigger price during those months. For fiscal year (FY) 2003, the average payment equaled \$1.59 per hundredweight. Payments were only paid on the first 2.4 million pounds produced during the FY.

Component Pricing

The average price paid per pound to producers for butterfat increased 1.4 percent in 2003. The per-pound annual average protein price actually jumped 20.4 percent from the previous year, while the annual average other solids price dropped 78.3 percent. This decline in the other solids price was largely due to the change in the price formula (effective April 1, 2003) that increased the make allowance and allowed the formula to reflect farm-to-plant losses. As a result, when market prices for dry whey declined, the formula reported a negative other solids price. This occurred for 4 months during 2003.

The annual average producer butterfat test was unchanged during 2003, although there were noticeable changes when comparing year-to-year monthly tests. The average producer protein test increased 2 percentage points, while the other solids test averaged 2 percentage points lower.

Receipts of Milk from Producers by State*, 2003

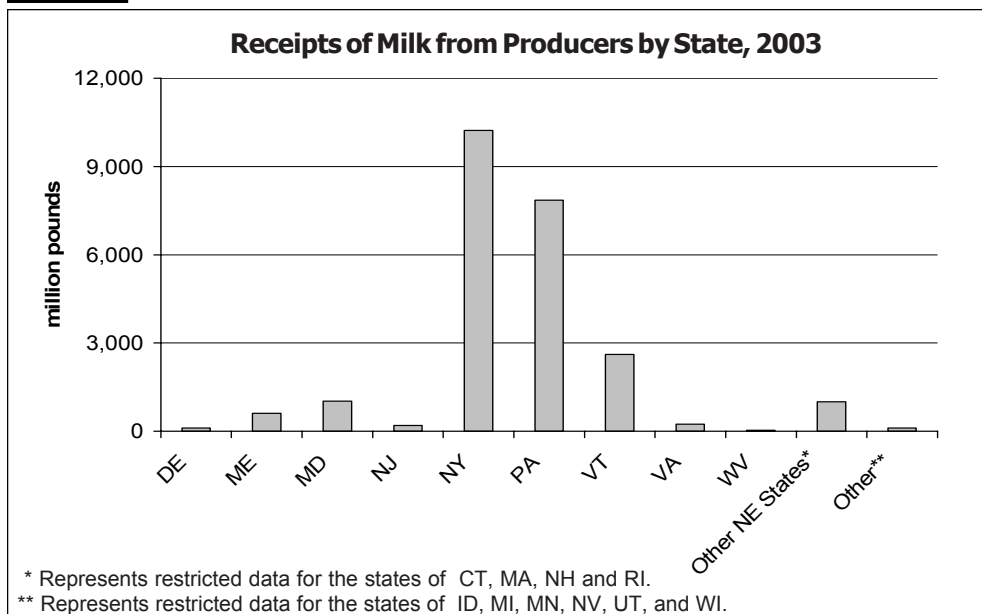

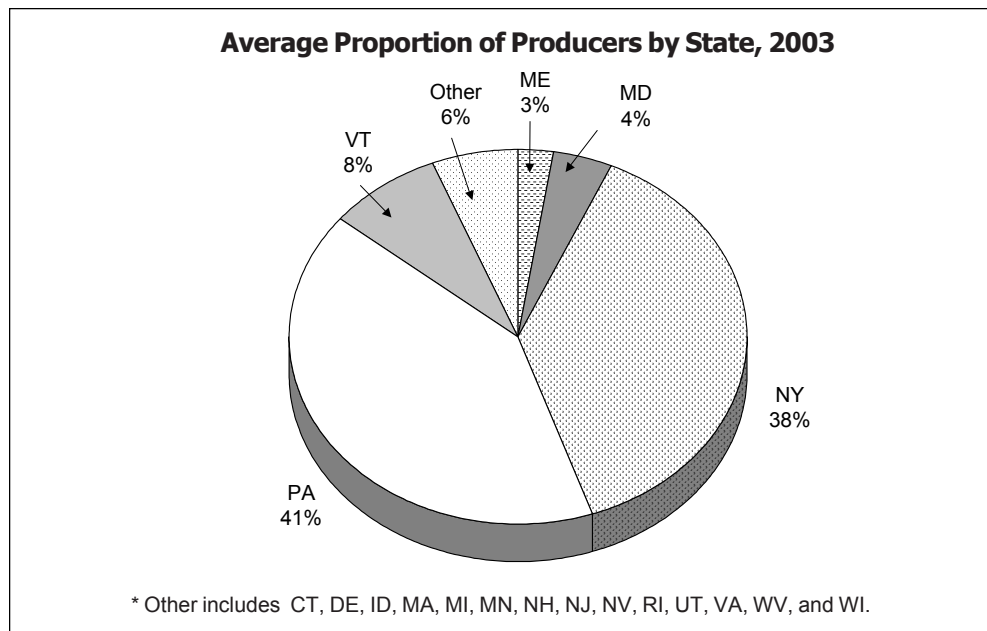

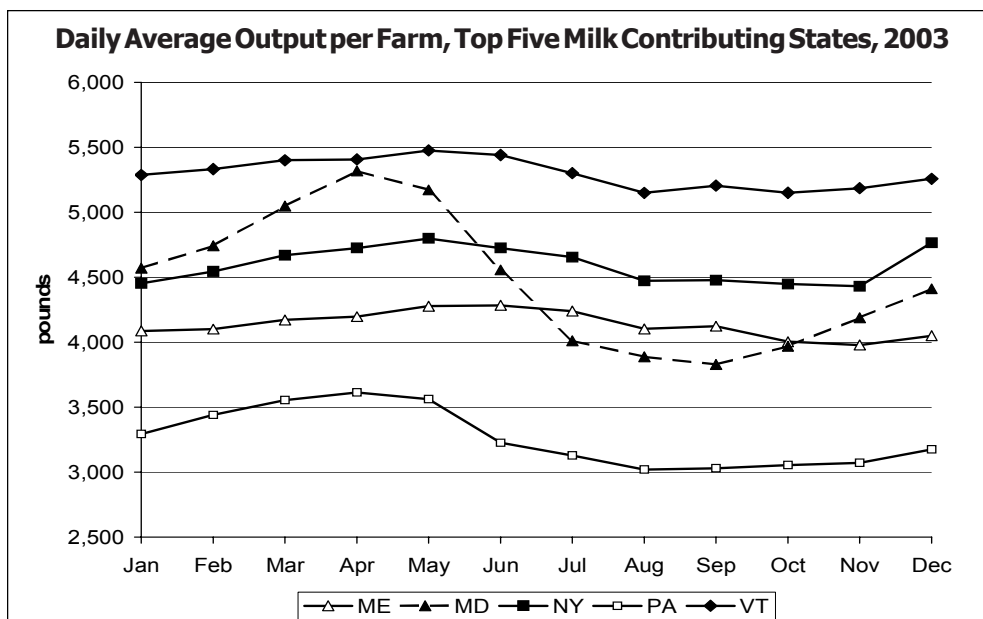

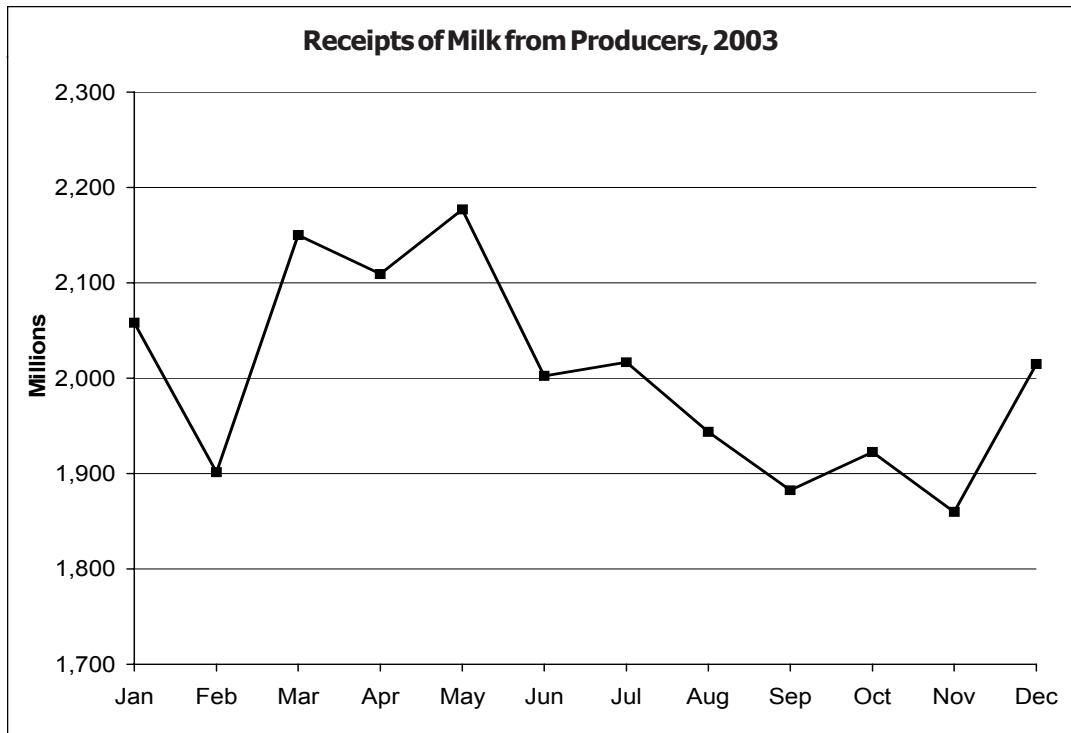

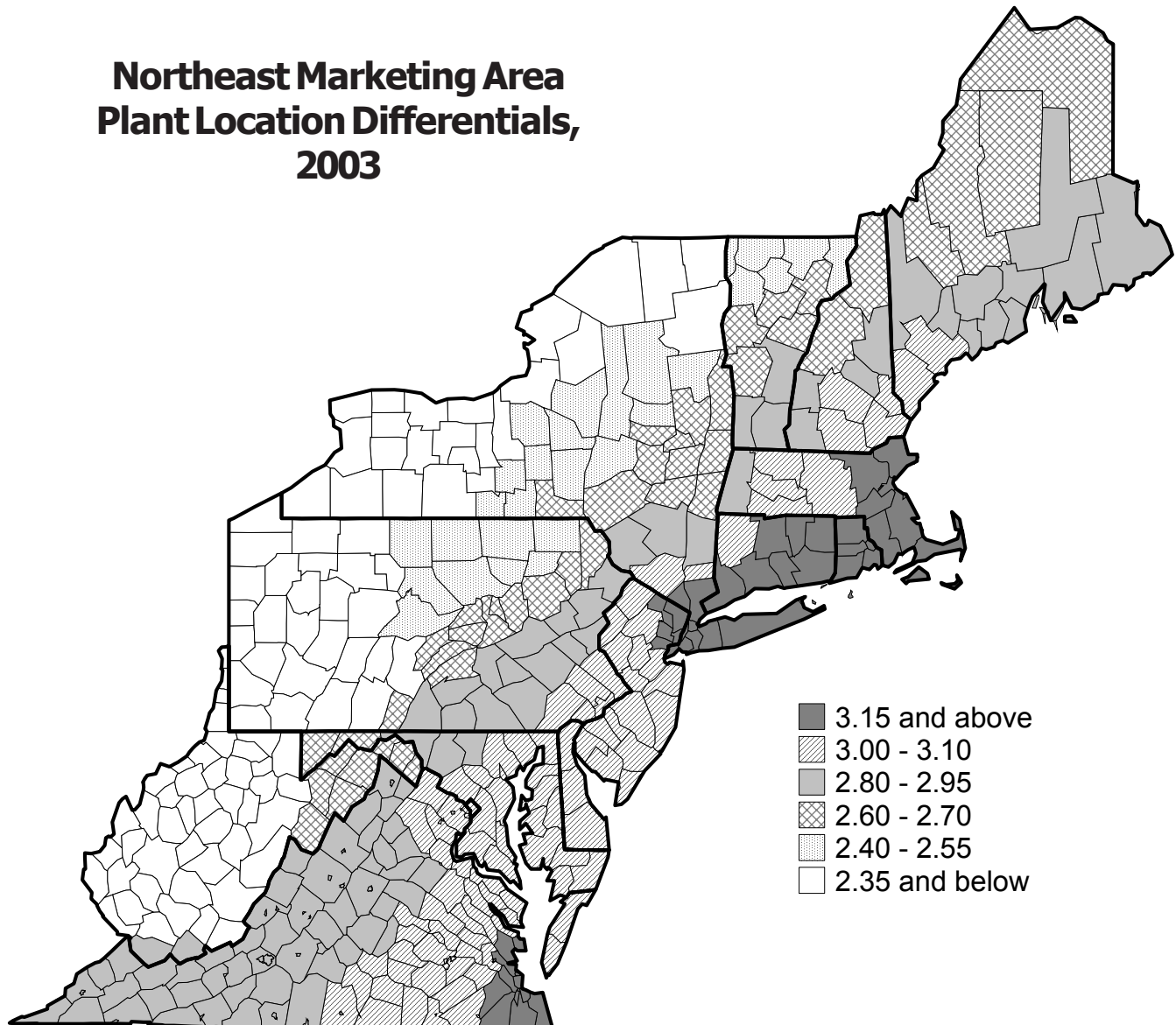

Bulletin Highlights—2003

January

Producers approved amendments to revising the Class III and IV price formulas. Effective for milk marketed on or after April 1, 2003, the formulas would increase component prices for protein and reduce the prices for butterfat and nonfat solids.

An analysis of the impact of the Milk Income Loss Contract Program (MILC) was given as well as sources of information on and requirements for signing up for the MILC program.

A map showed the counties in the Northeast Order with farms whose 12-month production was greater than 2.4 million pounds from October 2001 to September 2002.

USDA's Agricultural Marketing Service's Dairy Programs released a study of the Dairy Forward Pricing Pilot Program and its effect on milk prices paid to producers. A chart illustrated the average price at test from September 2000 to March 2002.

February

Total milk production in the United States grew during 2002; a table showed the top ten states ranked by milk production; and a map depicted the percent changed from 2001 to 2002.

MILC payments were discussed, and a table showed the actual and estimated payments from October 2002 to September 2003.

A pool summary for all federal orders, from 2001 to 2002, was shown in a table.

March

The April Class I price, which was announced on March 21, was the first price announced using the revised Class III and IV formulas.

The Market Administrator's bulk tank verification program was explained and a tentative schedule was given for 2003.

Growth and consolidation in federal milk orders was discussed, and a table showed changes for selected years from 1947 through 2002.

Weak demand for dairy products and the mixed signs for improvement were discussed. A table illustrated the U.S. milk commodity supply and use.

April

The combination of revised price formulas and low dry whey prices resulted in a negative other solids price for April. The formula used in the calculation of the other solids price was given, and its values were explained.

Shifts of the center of Northeast Order production were caused by milk pooled on the Northeast Order from

states not traditionally part of the Northeast milkshed. A map illustrated the weighted average production centers for January 2000 through January 2003.

USDA's National Agricultural Statistics Service (NASS) released their Dairy Products Annual for 2002; the publication summarized dairy products manufactured in the United States. A chart illustrated the whole milk equivalents used in manufactured products.

Cooperatives representing producers located in the Northeast held informational meetings on the Cooperatives Working Together (CWT) program, which is not a government program. The objectives of the program were given.

May

Milk production during the first 4 months of 2003 was compared to the same period in 2002. A table ranked the top ten states by milk production from January to April 2003.

The top ten contributing counties' producer milk receipts in the Northeast Order were shown for 2002. The accompanying figure included statistics on daily deliveries by producer and average herd size.

Cheese and butter prices on the Chicago Mercantile Exchange (CME) and NASS were compared for the first 5 months of 2002 and 2003.

June

The possibility of a negative producer price differential (PPD) was explained along with why a negative PPD would not result in producers receiving less money for their milk. A table gave the Northeast Order price estimates for July through September 2003.

A pool summary for all federal orders, January–June, 2002–2003, was given in a table.

Butterfat, protein, and other solids tests were discussed, and charts showed component tests for the year 2002 for selected milk marketing orders.

July

For the fourth month in a row, the component price for other solids was negative. The factors behind the negative price were discussed, and a table gave the component price differences under the new and old Class III and IV price formulas.

The average component tests for selected Northeast states/areas were compared. An accompanying map showed the weighted average of producer butterfat, protein, and other solids levels for April 2003.

The effect declining milk production during the first half of 2003 had on CME commodity prices for

cheese and butter was discussed. Charts depicted the average weekly cheese and butter prices for January through August 2003 vs. the average for 2000–2002.

August

For the first time in the Northeast Order, the PPD was negative in all differential zones. This signified that producers received a higher amount for their components (protein, butterfat, and other solids) than the pool generated.

A hearing was announced to convene on October 21, which would consider proposals to reclassify evaporated milk, sweetened condensed milk, and bulk ending inventory.

There was no MILC payment issued for milk produced in September 2003 because of the higher Class I price.

The total pay price to Northeast Order producers based on multiple component pricing (MCP) was discussed, and an example illustrated the composition of total gross payments for the month of August 2002 and 2003.

After 4 months of a negative other solids price, the August 2003 price was positive due to an increase in the average monthly dry whey price. Charts displayed the monthly dry whey and other solids prices and the NASS weekly dry whey price for January through August 2003.

Bulk milk movements by handlers pooled on the Northeast Order that were shipped to and received from handlers pooled on other federal orders during August was discussed and compared to prior years.

September

The deadline for submitting additional proposals in connection with a hearing that would amend the fluid milk product definition in all federal milk marketing orders was extended from September 19, 2003, to January 30, 2004.

The USDA named seven new members and reappointed five incumbents to the National Dairy Promotion and Research Board.

USDA released an update to the study of the Dairy Forward Pricing Pilot Program. Prices received by a hypothetical farm were compared over the 28 months covered in the study. A chart illustrated the average prices at test for contract price, non-contract price, and federal order minimum from September 2000 to December 2002.

Commodity Credit Corporation (CCC) purchases for marketing year 2002–03 were discussed. A table showed CCC dairy products purchases from 1991

through 2003.

A pool summary for all federal orders, January–September, 2002–2003, was given in a table.

October

The USDA sought nominations for the National Fluid Milk Processor Promotion Board. Seven individuals would be appointed to serve 3-year terms beginning July 1, 2004.

National milk production was up slightly for the first 9 months of 2003 compared to the same period in 2002. A map illustrated the changes in milk production by region from January–September 2002–2003.

MILC payments were discussed, and a table gave the total MILC payments for fiscal year 2003.

Block Cheddar and Grade AA butter prices on the CME were discussed, and charts compared the prices for 2002 and 2003.

November

A calendar was given for 2004 that showed the payment dates for partial and final payments to producers who are not members of cooperatives.

Some producers exceeded the MILC cap at some point during FY 2003. A table showed how many producers reached the cap during each quarter and the average MILC payment during FY 2002–2003.

Farm operations that marketed more than 1.5 million pounds of milk per month on the Northeast Order were discussed. A table showed the total pounds of milk pooled by these farms by state for the month of May 2001–2003.

The 2003 Northeast Regional Dairy Outlook Conference was held November 18 at the Albany office. A table showed the statistical uniform prices for the years 2002 and 2003, with the 2004 estimated prices.

December

The Northeast Order statistics for 2003 were summarized; class utilization, milk production, component pricing, and producer changes were discussed. A table gave the Order pool statistics for 2002 and 2003.

Class I sales declined in 2003. A table showed total and per capita sales of fluid milk products in the Northeast milk marketing area for 2002 and 2003.

The Market Administrator's market services verification and calibration programs were discussed. A table gave the tanker calibration work by tank size for 2003.

A pool summary for all federal orders, 2002–2003, was given in a table.
