

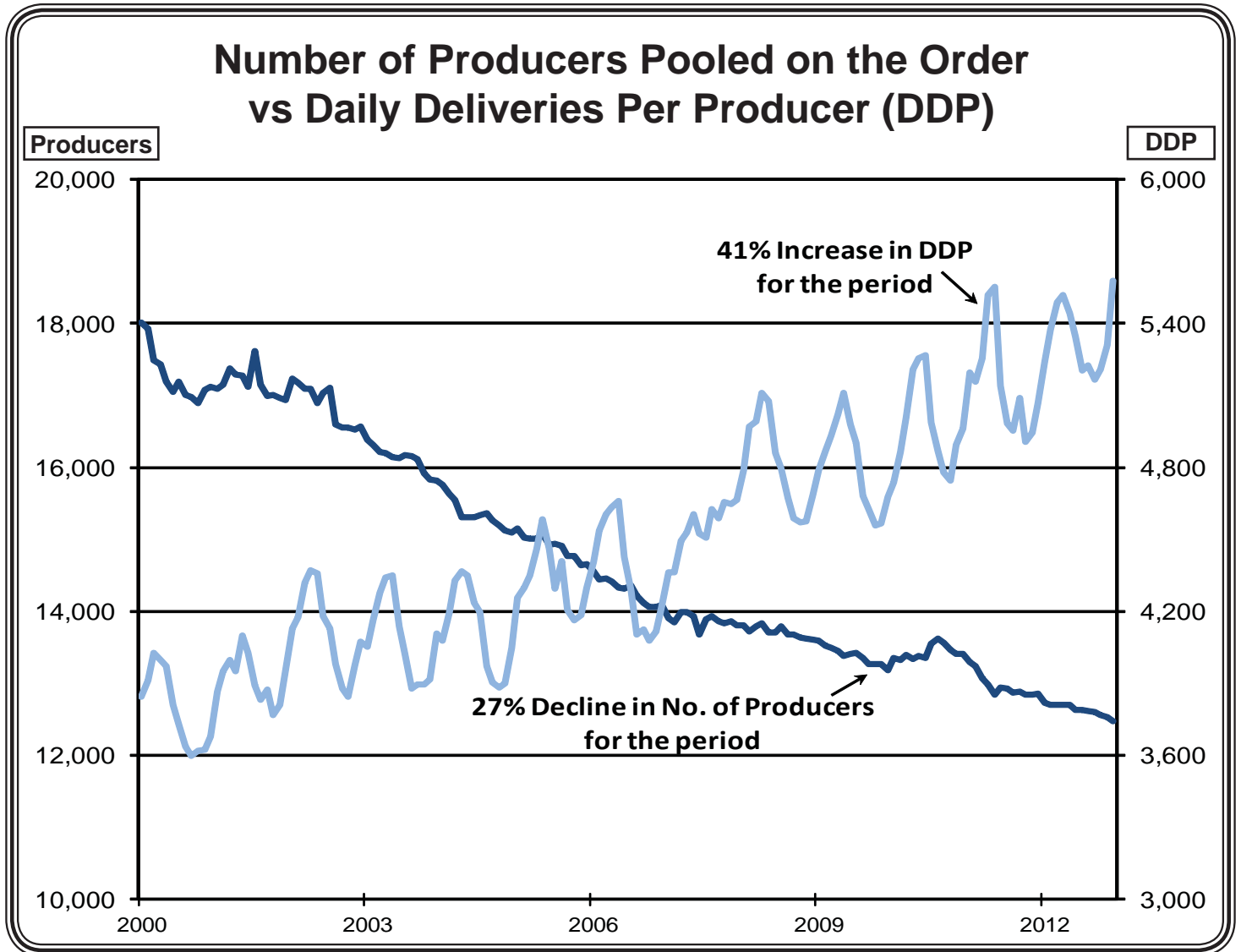

## Summary

This bulletin provides information about the operation of the Northeast Order during 2012 through a series of tables and charts. The *Bulletin* Highlights section summarizes important events that impacted the dairy industry in 2012. Also included are lists of handlers and cooperatives operating under the Order with their respective locations depicted on a map of the region.

### **Producer Milk Receipts Increase**

During 2012, the volume of milk received from producers shipping to handlers regulated under the Northeast Order increased 1.1 percent from the previous year. There were no major plant pooling changes during 2012 that impacted the volume of pooled milk. Most of the increase was the result of growth in milk production in the Northeast states. Comparisons have been adjusted for leap year in 2012.

Nationally, total milk production grew 1.8 percent in 2012, about the same as the previous year. In the Northeast, the milkshed states' production grew 0.9 percent. The main contributing states (New York, Pennsylvania, and Vermont) had a combined increase in production of 1.0 percent; milk pooled on the Order from these states rose 1.4 percent. This reflects changes in pooling from other federal or state orders. Milk pooled on the Northeast Order from outside the milkshed declined 26.2 percent; this included shipments from producers located in Indiana, Kentucky, Michigan, Minnesota, North Carolina, and Ohio.

The year ended with 373 less producers than at the end of 2011. Annual average daily deliveries per producer (DDP) equaled 5,341 pounds, an increase of 3.8 percent from 2011 and a new record for the Order.

### **Class Utilization Changes**

Class I utilization averaged 39.7 percent in 2012, a decrease of 1.7 percentage points from the previous year; the total volume of milk used in Class I declined 3.0 percent. Class II usage jumped 11.7 percent, resulting in overall utilization of 25.9 percent, an increase of 2.4 percentage points. Total Class II volume equaled 6.4 billion pounds, surpassing the total Class III volume (5.8 billion pounds) for the first time since the Order's inception. The continued growth in Greek-style yogurt largely was the driving force behind the substantial increase in the Class II volume during the past three years. Class III volume declined 4.3 percent with utilization averaging 23.7 percent, down 1.4 percentage points. The amount of milk used in Class IV grew 6.7 percent and accounted for an annual average of 10.7 percent utilization, up 0.5 percentage points.

### **Prices Decline**

Even though commodity prices were generally lower than during 2011, they were still higher than in most years, ranking in the top third over the past thirteen years. Correspondingly, component and class prices followed a similar pattern resulting in the third highest blend price since the Order's inception.

The Class I price averaged \$20.71 per hundredweight (cwt) in 2012, \$1.67 (7.5 percent) below the 2011 annual average. The Class II price averaged \$16.64 per cwt, \$2.98 and 15.2 percent lower than the previous year. The Class III price averaged \$17.44, down \$0.93 and 5.0 percent from 2011. The Class IV price dropped \$3.03, a decline of 15.9 percent, and averaged \$16.01 per cwt. The Class II, III, and IV prices were the third highest for their respective categories; the Class I price was the fourth highest average on record.

Overall, the statistical uniform price (blend) reported at Suffolk County, Massachusetts (Boston) averaged \$18.63 per cwt, the third highest since the Order's inception. During 2012, the blend averaged over \$20.00 per cwt 3 months, compared to 9 months in 2011 and 7 months in 2007.

### **Component Pricing**

With commodity prices declining for butter, cheese, and nonfat dry milk, component prices for butterfat and nonfat solids declined. With the dry whey price increasing and the formula for protein that incorporates the butterfat price, both the producer other solids and protein prices averaged higher in 2012.

The price paid to producers for butterfat averaged \$1.7230 per pound, 20.0 percent lower than in 2011. The annual average protein price was \$3.0426 per pound (third highest on record), up 2.6 percent from 2011. The other solids price increased 18.3 percent and averaged \$0.4063 per pound, the second highest other solids price ever. The nonfat solids price declined 13.3 percent and averaged \$1.1485 per pound, but still the third highest reported.

### **Producer Tests**

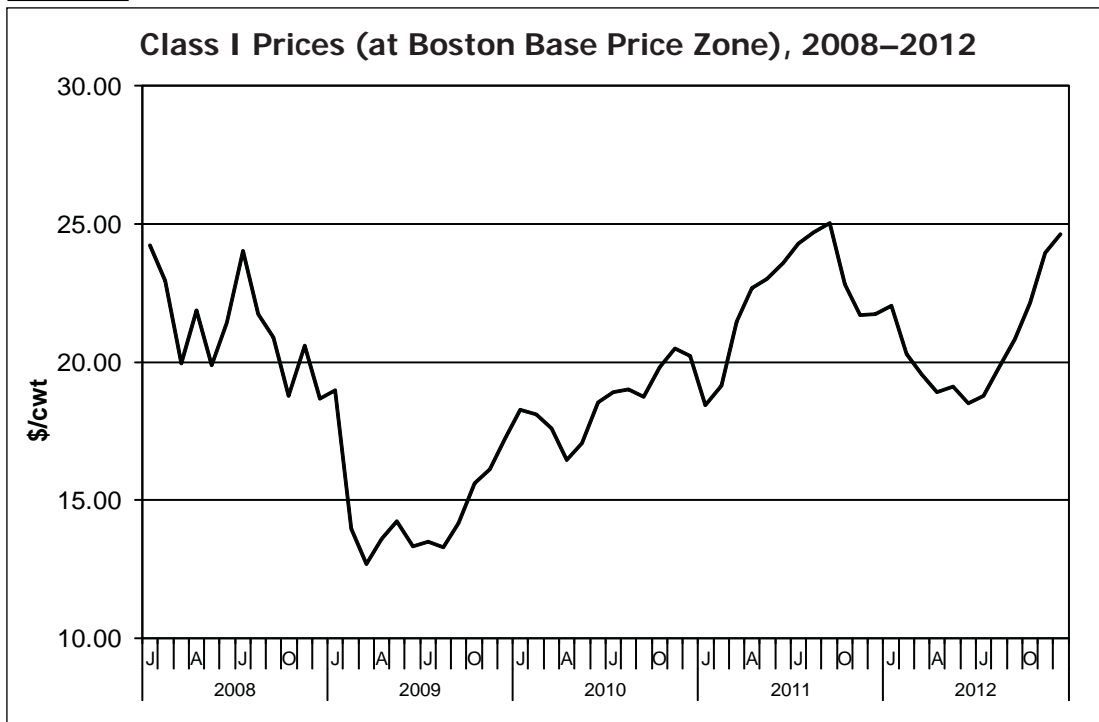
The annual average producer butterfat test equaled 3.73 percent in 2012, unchanged from last year and tied with both 2011 and 2008 for the highest annual average. Records were set during October and November of 2012. The annual average producer protein test was 3.06 percent, down 1 percentage point from 2011's record for the Order. The only record-setting month was November. The annual average producer other solids test increased 2 percentage points to 5.75 percent, setting a new record high annual average. Record highs were set or tied with previous records in ten months of 2012.

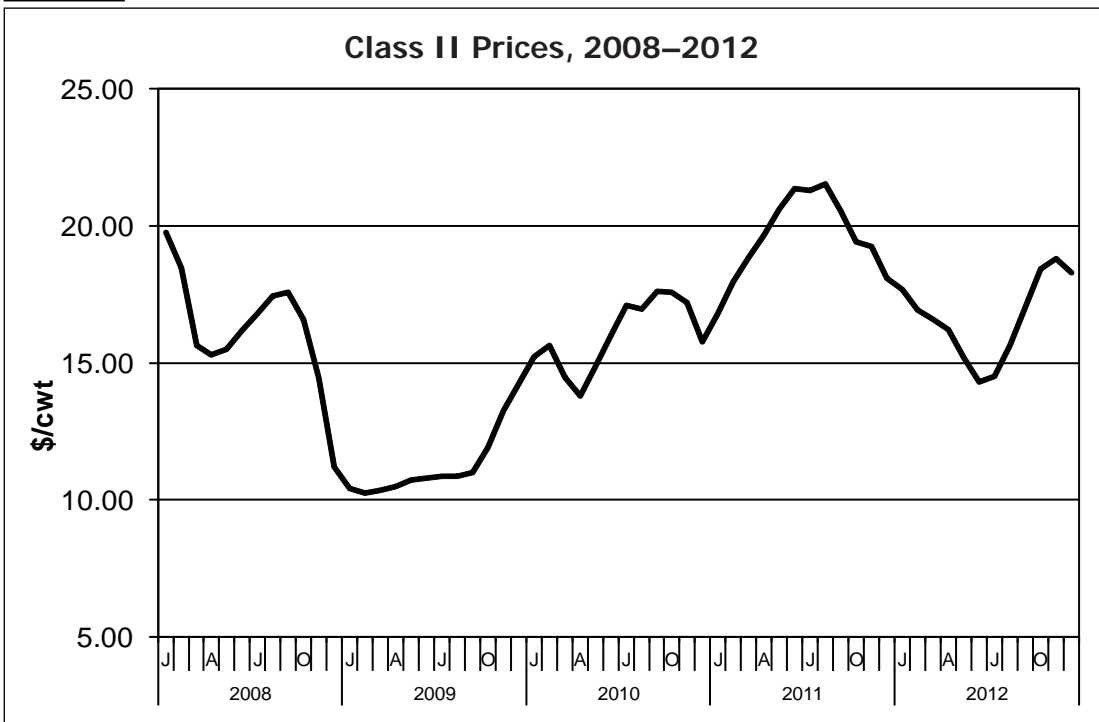

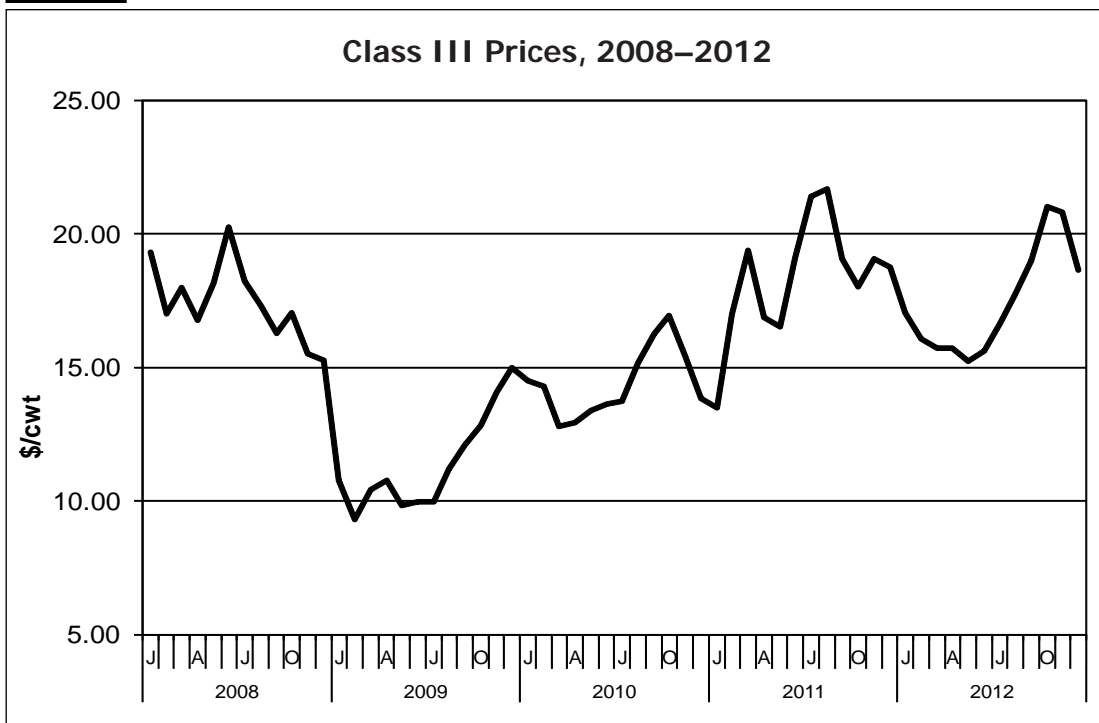

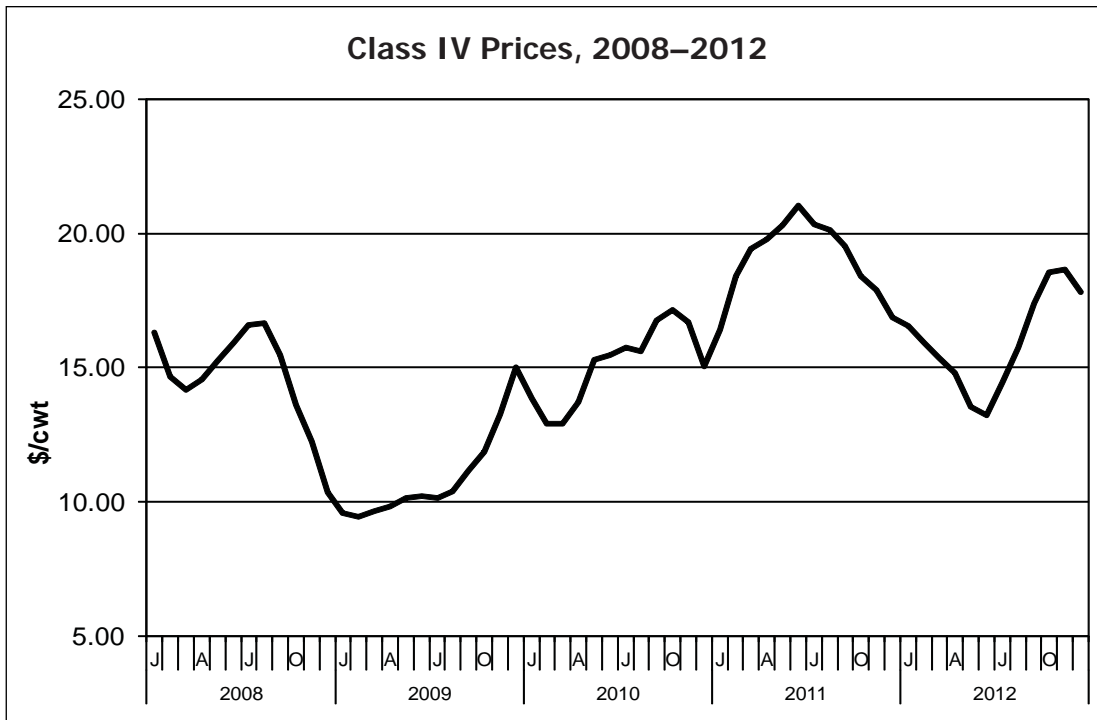

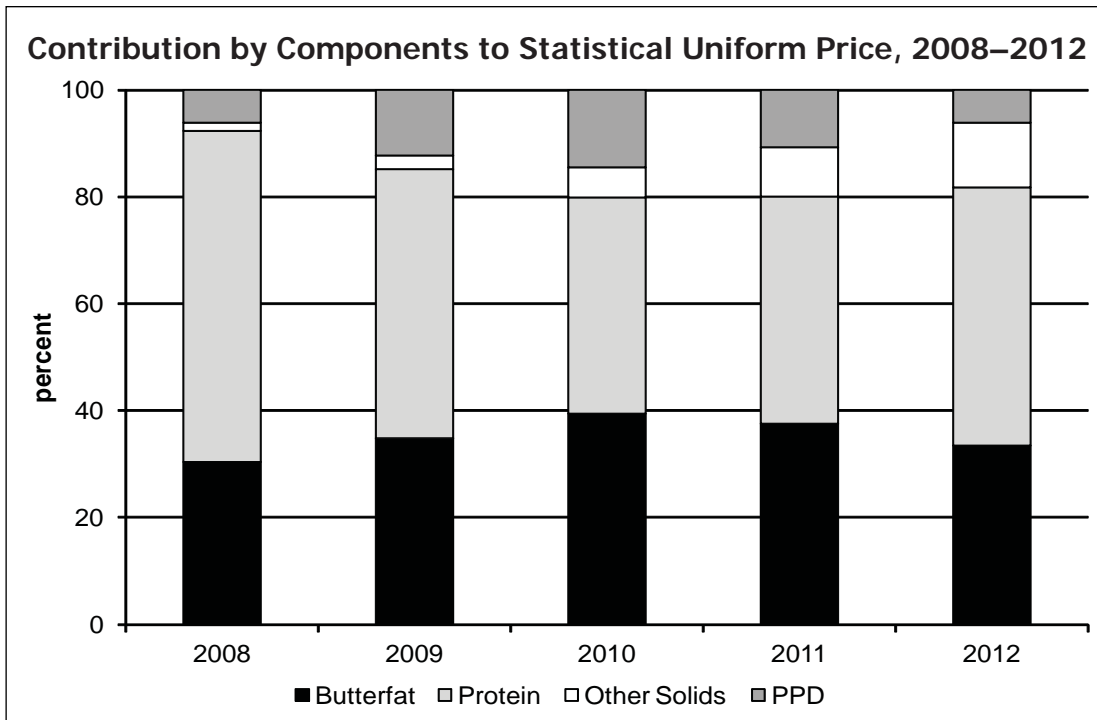


**5** **Producer Prices at Suffolk County, MA (Boston), 2008–2012**

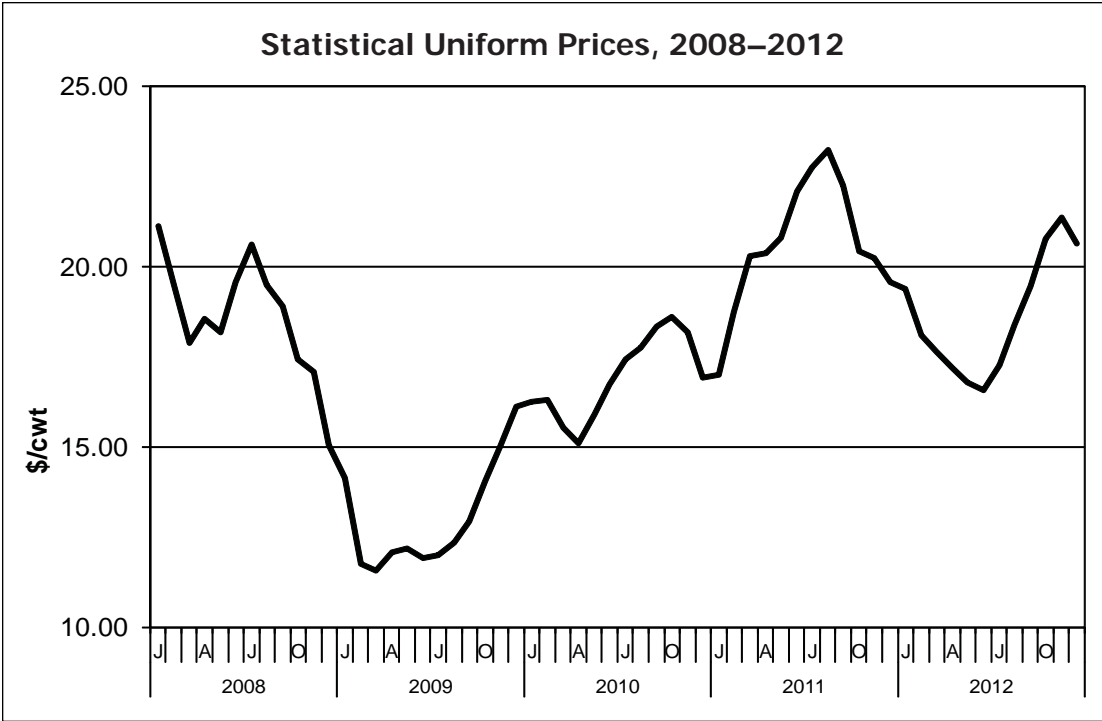

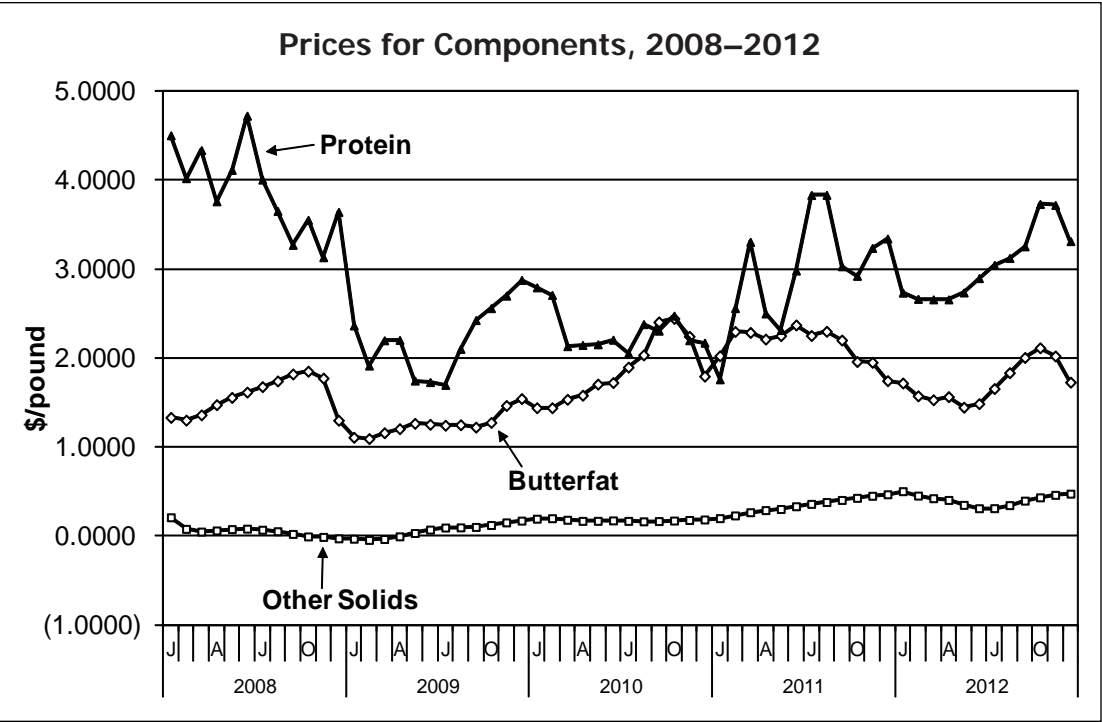

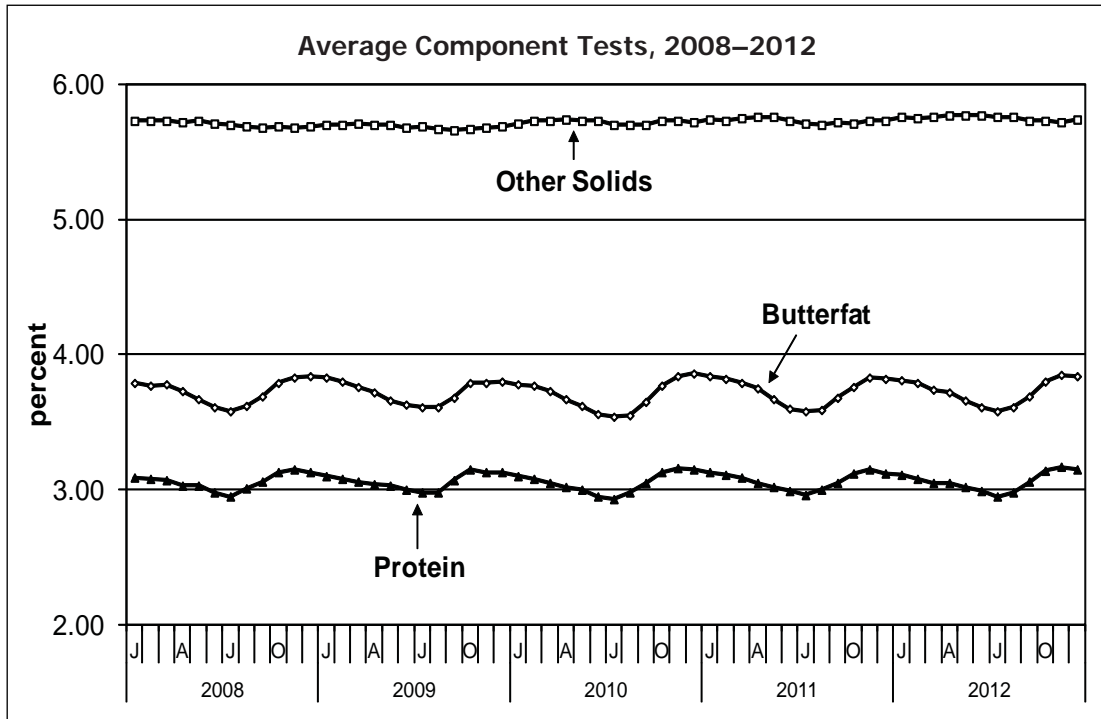

**9 Receipts of Milk from Producers, by State\*, 2012**

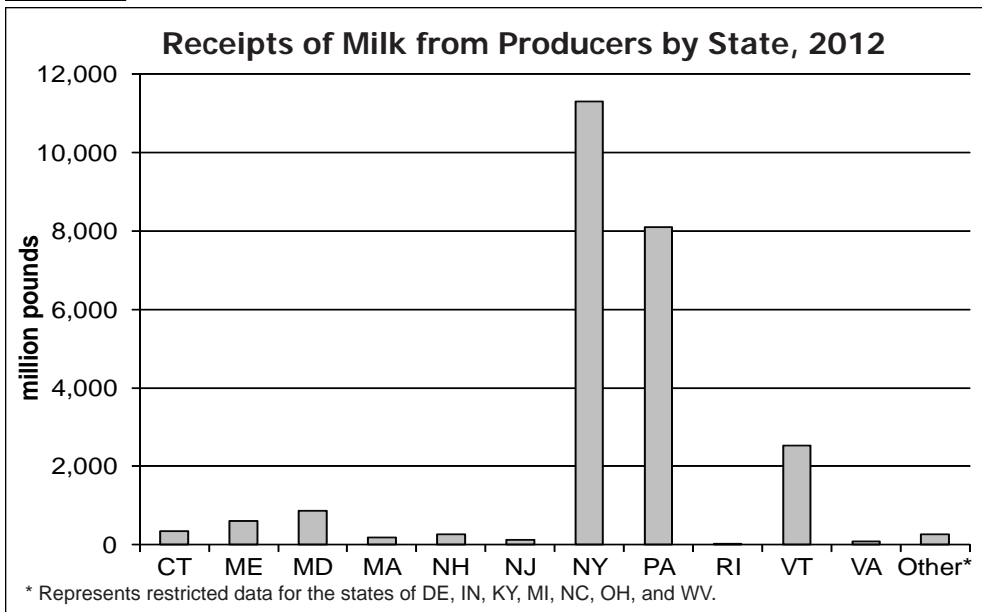

**10** Number of Producers, by State\*, 2012

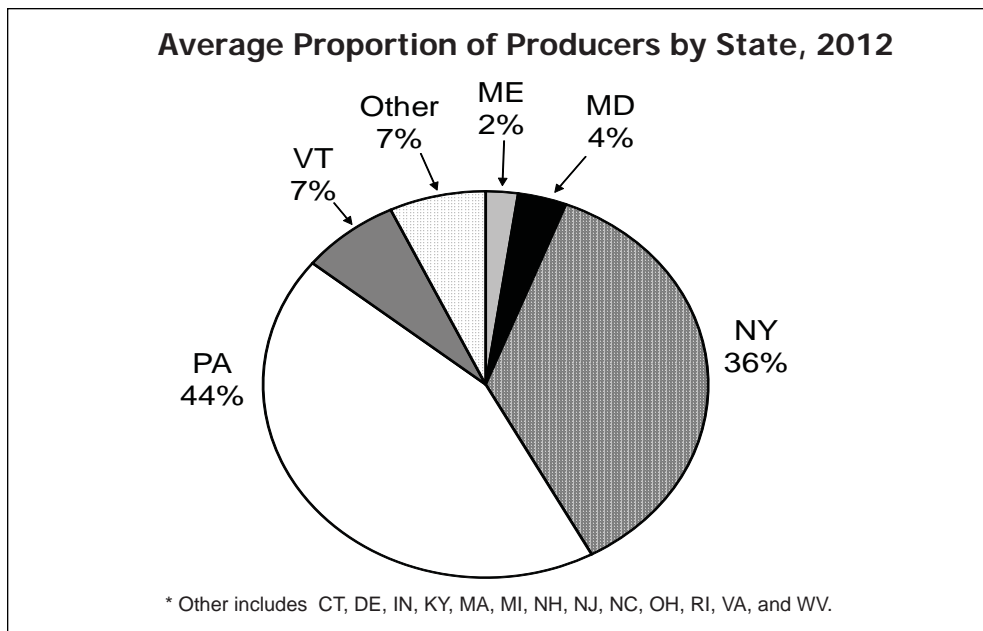

**11 Daily Average Output of Producer Milk per Farm, by State\*, 2012**

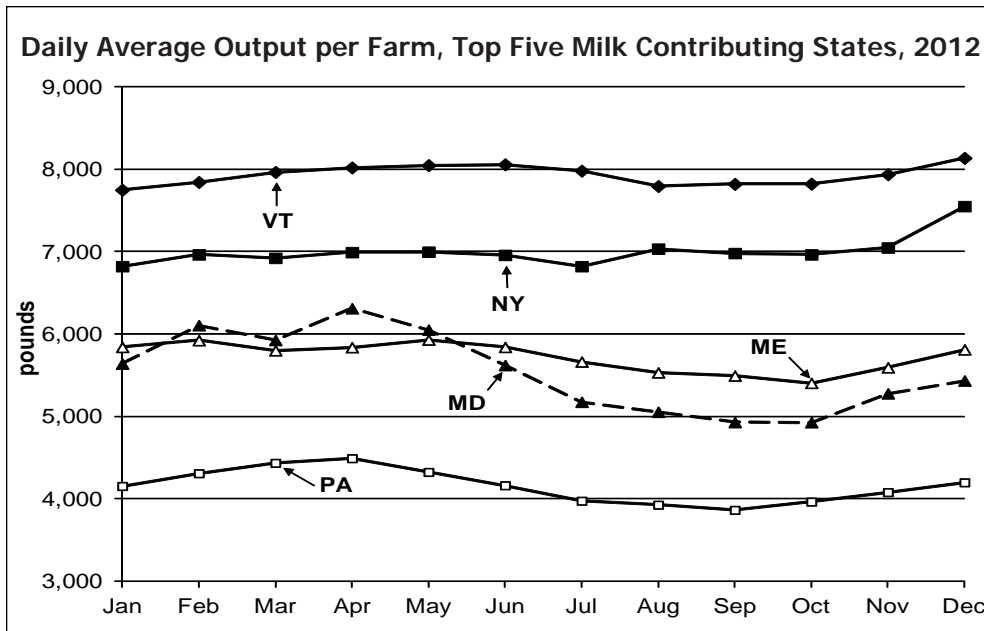

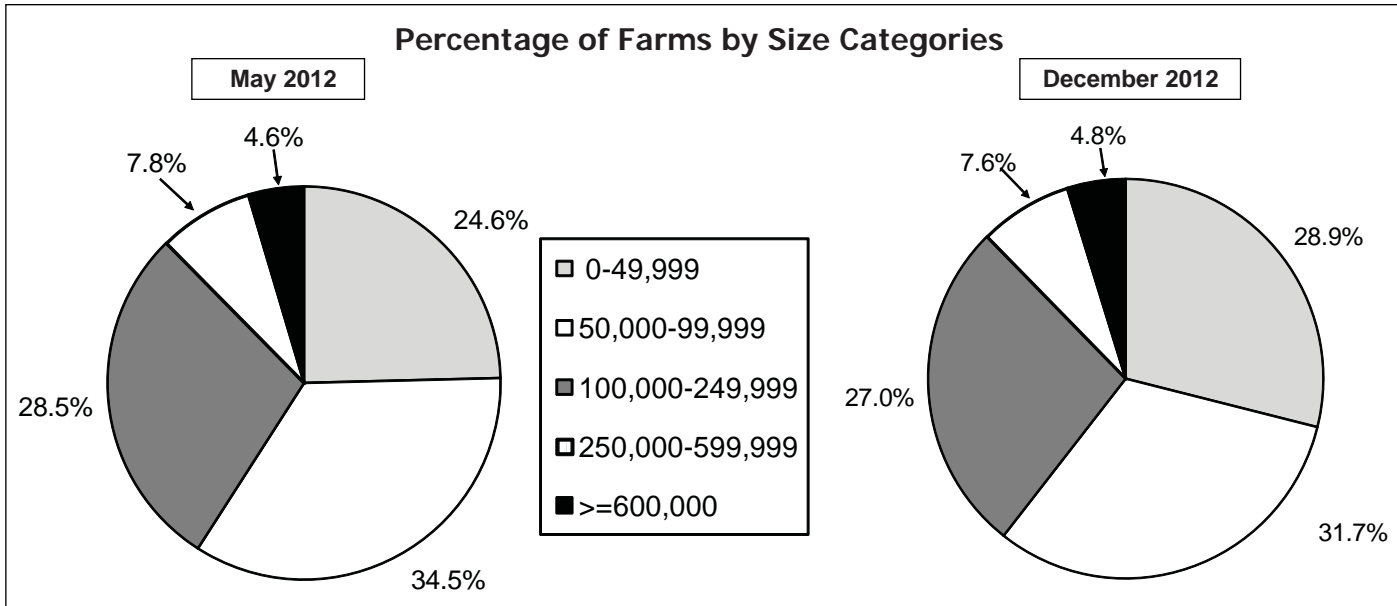

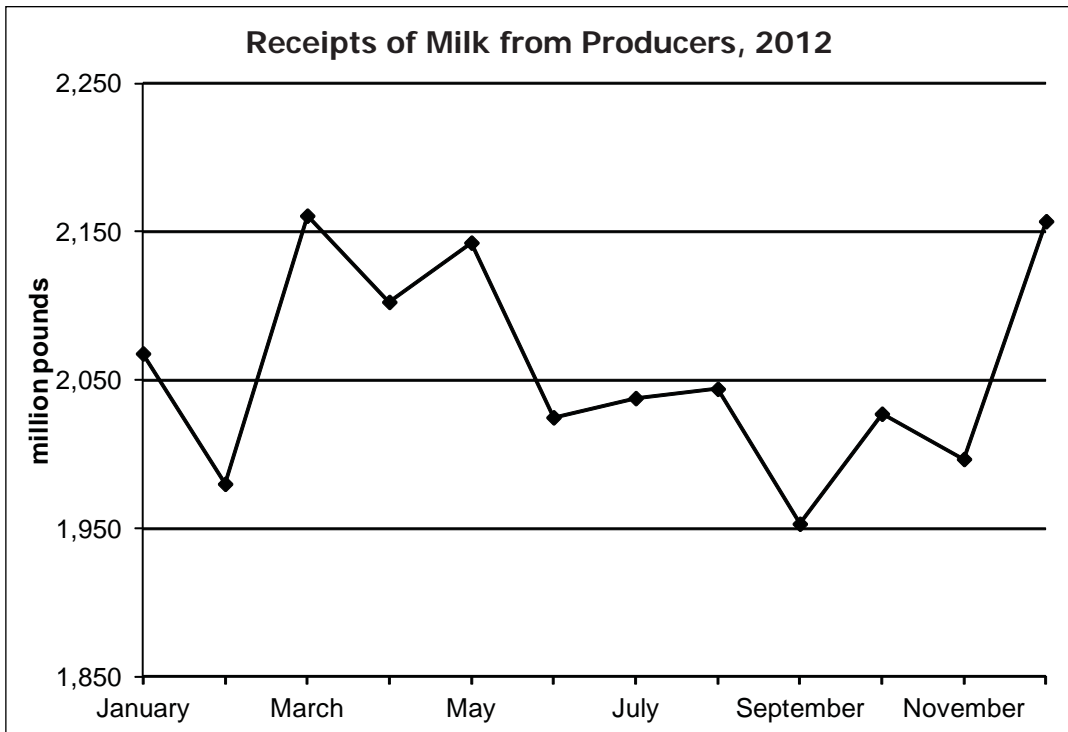
**Figure 13**

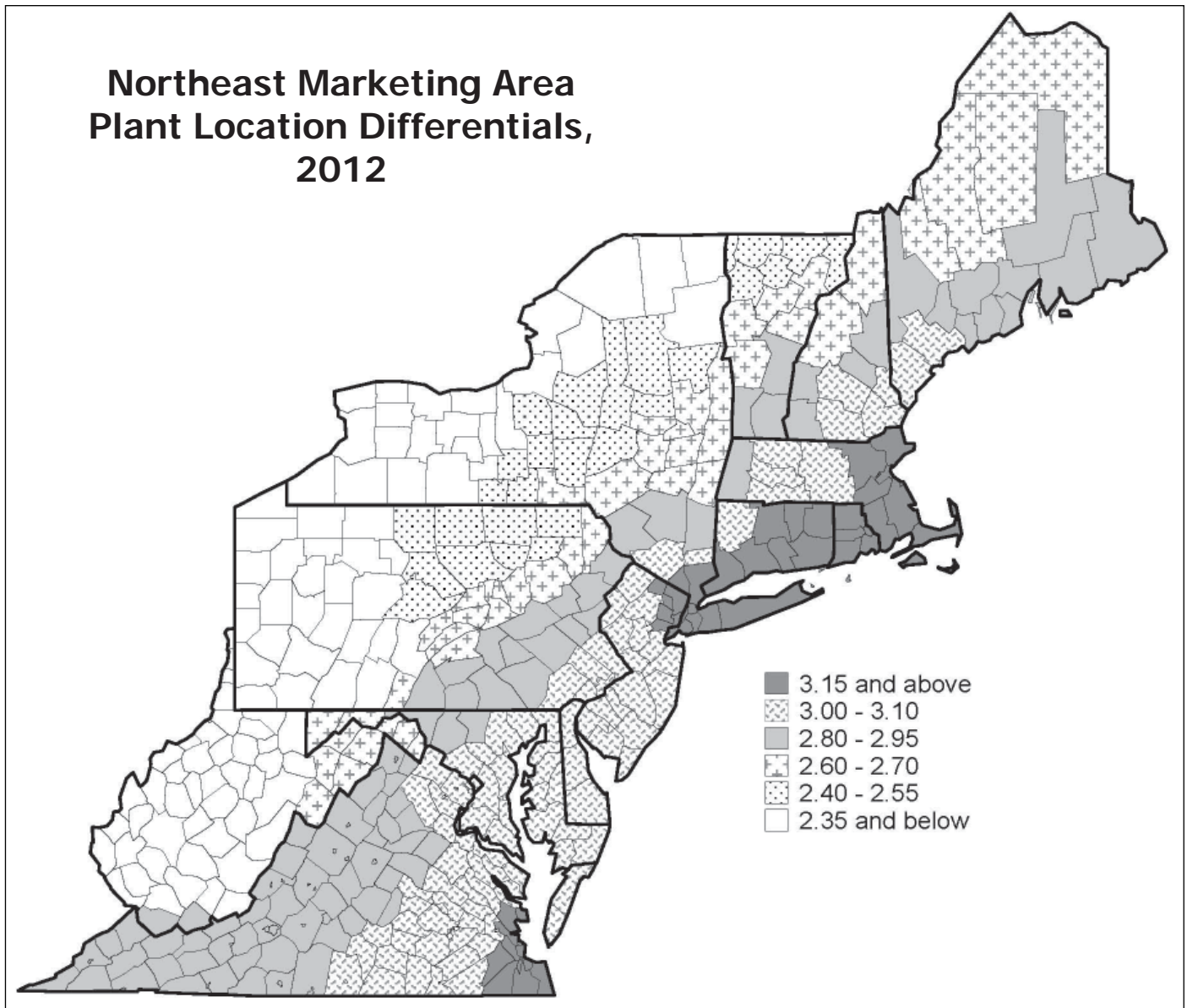

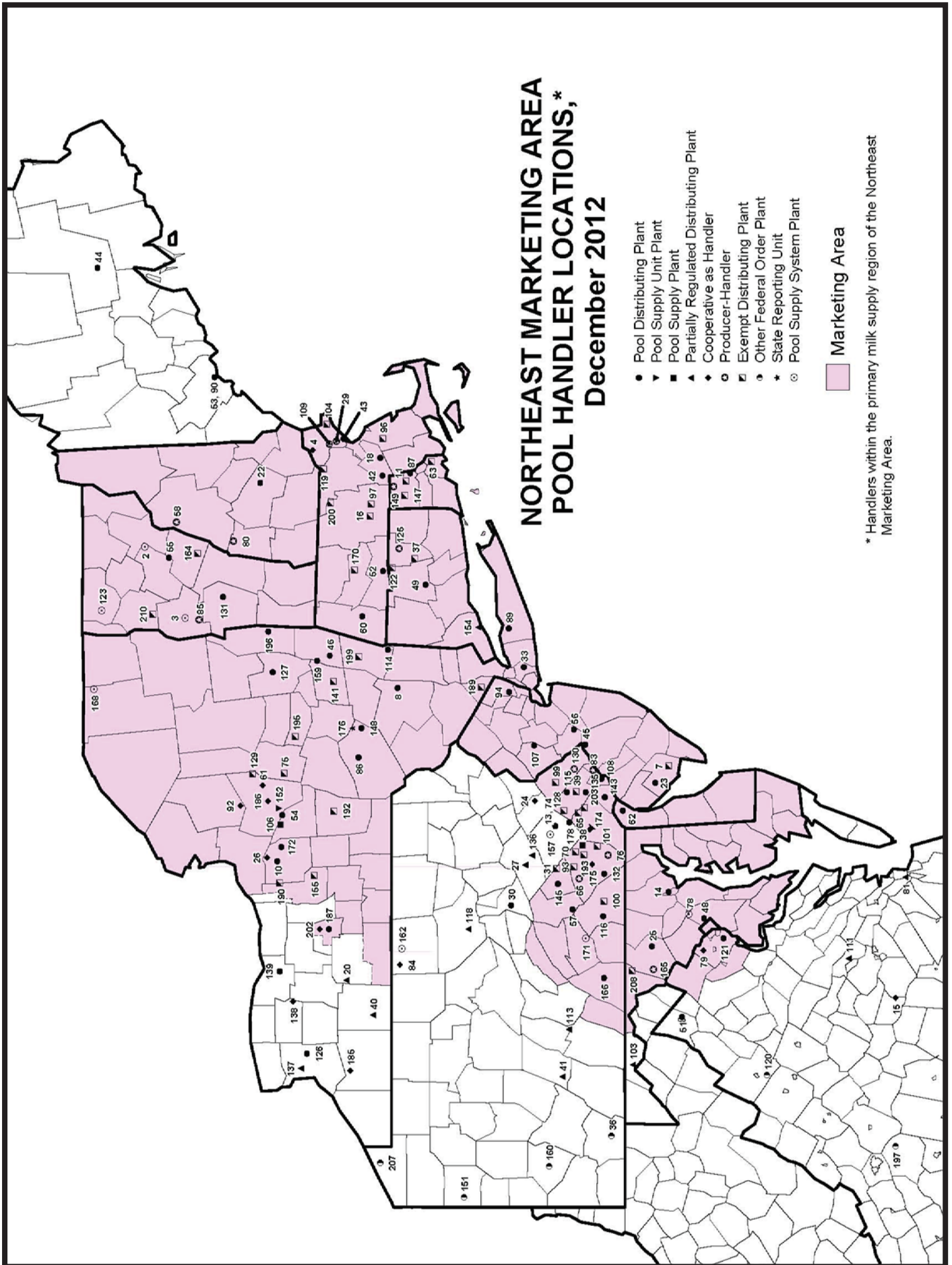

## Bulletin Highlights —2012

### January

USDA issued a final rule to amend the Dairy Product Mandatory Reporting Program, establishing an electronic reporting system and transferred data collection responsibilities from the National Agricultural Statistics Service (NASS) to the Agricultural Marketing Service (AMS). Release dates for price announcements changed from Friday to Wednesday.

Sales of Class I fluid milk products for 2011 were compared to 2010. Volume and percent change were shown in a table along with proportion of total estimated U.S. sales and per capita sales.

The market service department checked 368 farm bulk tanks throughout the Northeast Marketing Area milkshed during the 2011 season. A chart illustrated the 2011 tank checks and calibrations. The tentative calibration truck schedule for 2012 was announced.

### February

Milk price projections and feed prices based on Chicago Mercantile Exchange (CME) future prices were discussed for 2012. Milk Income Loss Contract (MILC) payments were projected for most of 2012.

U.S. milk production increased 1.8 percent in 2011. A table ranked the top ten states by 2011 production.

The top ten counties in terms of milk pooled on the Northeast Order accounted for 33.6 percent of all milk pooled in 2011. A table illustrated the top ten counties pooling on the Order for 2011.

### March

USDA announced that the dairy product price series in the *National Dairy Products Sales Report* (NDPSR) released by the AMS was equivalent to the price series previously released by the NASS.

MILC payments were triggered for the month of February 2012 and predicted to last much of the year based on CME future prices. A chart illustrated actual and projected Boston Class I prices versus the feed-adjusted MILC triggers from January 2011 through October 2012.

The results of the November 2011 biennial container sales survey for the Northeast Milk Marketing Area were reported.

A pool summary for all federal orders was given in a table for January–March, 2011 and 2012.

### April

The Class I volume for the month of April 2012 was the second lowest on record. Its impact on the statistical uniform price (SUP) was discussed.

A discussion compared milk pooled in the Northeast for the first quarter of 2012, the same period in 2011, and U.S. milk production. A table showed the year-to-year percent change of milk production in the top 23 milk-producing states in 2011 and comparisons to other years.

The relationship between manufacturers' nonfat dry milk (NFDm) stocks and milk production was discussed. A chart illustrated total NFDm stocks versus the Northeast Order uniform price for January 2006 through January 2012.

### May

Northeast Order milk receipts appeared to support the dairy discussion about an earlier-than-typical spring flush in 2012. A chart showed Northeast Order total milk receipts standardized to 31-day months for January through May 2012.

Class I milk receipts in the Northeast Order's highest differential zone declined from 33.2 percent in 2001 to 22.3 percent in 2011; increased Class I in other zones was discussed. A chart showed Class I milk receipts by destination differential zone for 2001 and 2011. A map illustrated pool distributing plant closings in the Northeast Order from 2001 through 2011.

USDA released their *Dairy Products 2011 Summary*, a publication reporting dairy products manufactured in the United States. A table showed a year-to-year comparison of selected U.S. manufactured dairy products percent change from 2006 and 2010 to 2011.

### June

USDA announced a Final Decision that amended the pool plant definition of the Mideast Milk Marketing Order.

The June Northeast Order uniform price declined about 30 percent since September 2011's peak. Higher price projections, weather impacts, and demand signals for dairy products were discussed. A chart illustrated actual and projected uniform prices with and without MILC payments for 2012.

Despite changes in pooling plants and producers, milk pooled on the Northeast Order remained fairly consistent since the formation of the Order in 2000. Charts illustrated receipts of milk from producers

pooled on the Order, number of producers versus daily deliveries per producer (DDP), and DDP for selected states, from January 2000 through June 2012.

### **July**

The producer price differential (PPD) equaled \$0.58 per hundredweight (cwt) for July 2012. The resulting negative PPDs in outer zones were explained. Based on CME futures prices, negative PPDs for some outer zones were predicted to continue for the next couple of months.

The market situation was updated and discussed. The Northeast uniform price increased over the previous month for the first time since August 2011. A table showed actual and estimated feed, class, uniform, and MILC prices from April through December 2012, with an annual average for 2012.

The contribution to the SUP by components was discussed and a table showed the contribution by component for the month of July in 2001, 2010, and 2012.

A pool summary for all federal orders was given in a table for January–June, 2011 and 2012.

### **August**

The PPD equaled \$0.67 per cwt for August 2012. The resulting negative PPDs in outer zones (\$2.50 or less) were explained.

Class I utilization continued to decline; trends were discussed. Charts illustrated Class I utilization from January 2008 to August 2012 for the Northeast, Upper Midwest, and Florida Federal Orders, and the California State Order, and Class I utilization for all Federal Orders combined.

The August Class II price was the lowest of the class prices; the Class II price calculation was explained. A table showed the prices reported on the NDPSR and the averages used in calculating the Class II price. A chart illustrated the NFDm and butter prices from June 30 through September 8, 2012.

### **September**

An explanation was given on why fall months' percentage of milk that pool supply plants and cooperative Section 1000.9(c) handlers must deliver to Class I pool distributing plants increases. Even with varying and declining production volumes over the years, the needs of the Class I handlers have been met without any administrative intervention since 2001.

The September uniform price was \$19.45 per cwt, the highest uniform price for 2012, to date. The market

situation, actual-versus-estimated prices, and end-of-year uniform price projections were discussed. An accompanying chart illustrated actual and projected Northeast Order uniform prices for 2012.

On October 1, 2012, many programs and policies of the USDA authorized under the Food, Conservation and Energy Act of 2008 (2008 Farm Bill) expired, including the Dairy Forward Pricing Program and the MILC program. Federal milk marketing orders are authorized under a separate permanent law; therefore, they are not directly affected.

A pool summary for all federal orders was given in a table for January–September, 2011 and 2012.

### **October**

The total volume of pooled milk receipts on the Northeast Order, for January through September 2012, declined from the same time period in 2011. A map illustrated Northeast Order location differentials and a chart showed the change in pooled milk by differential zone for the first 3 quarters of 2009 and 2012.

The SUP was \$20.78 per cwt and the PPD equaled a negative \$0.24 per cwt for September 2012. The scenario of a higher SUP with a negative PPD was explained.

A calendar showed the 2013 dates for partial payments to producers who are not members of cooperatives. The Order requirement was explained.

### **November**

The 2012 Northeast Regional Dairy Outlook Conference was held on November 28 at the NASS New York field office. A table showed the statistical uniform prices for 2011, the actual and estimated prices for 2012, and the estimated prices for 2013.

The dynamics of the rise and fall of the components used to calculate the PPD were explained. Charts illustrated the weighted average cheese price, advanced prices, class prices, and the uniform price for 2012.

### **December**

Selected Northeast Order statistics for 2012 were summarized, and a table compared the Order's pool statistics for 2011 and 2012.

The market service department checked 357 farm bulk tanks throughout the Northeast Marketing Area milkshed during the 2012 season. A chart illustrated the 2012 tank checks and calibrations by tank size.

A pool summary for all federal orders was given in a table for January–December, 2011 and 2012.
