MILK PRODUCTION REQUEST FORM (For Retired Producers or Producers Without a Current Handler)

This form may be used by a retired producer¹ or a producer without a handler affiliation seeking to obtain their milk production history as a producer whose milk was pooled on the Northeast Federal Milk Marketing Order (Northeast Order) and whose farm is physically located within the geographic marketing area of the Northeast Order, as defined under §1001.2 of the Order.

Such requests for milk production records have been made in consideration of the <u>Dairy Farmers of America</u>, <u>Inc. (DFA) and Dairy Marketing Services</u>, <u>LLC (DMS) Settlement</u> (in the case of Allen et al v. Dairy Farmers of America, et al. No. 5:09-cv-230 (U.S. District Court for the District of Vermont)) and the requirement for producers seeking to receive a payment from the settlement to provide "the total amount of Grade A milk produced and pooled in the Northeast any time from January 1, 2002 to December 31, 2014."

The Office of the Northeast Federal Milk Market Administrator offers to provide production data² by year and month to producers, whose milk was pooled on the Northeast Order, as a service to such retired producers requesting historical production records. The Northeast Federal Milk Market Administrator's office has no financial, or other, legal interest, or involvement in this case or settlement.

Records to Be Provided

Upon receipt of a completed form, the Office of the Northeast Federal Milk Market Administrator will compile a summary of the person's milk production, as reported to the Market Administrator by regulated handlers, for all months during the settlement period in which the person was a producer with milk pooled on the Northeast Order. In the event of a person with multiple farm bulk tanks, multiple farm locations, or multiple handler associations, an attempt will be made to collate production records into a single consecutive production history for the requesting person. It is the obligation of the producer to verify the accuracy of production records.
