2008 Federal Milk Marketing Order Price Information

The following tables indicate the dates on which federal order price data will be released during January through December 2008.

Release Dates

The advanced prices and pricing factors will be released at 10:00 a.m. EST/EDST no later than the 23rd of the preceding month if that date is on a Friday; otherwise, the release date will be the nearest Friday before the 23rd.

The class and component prices will be released at 10:00 a.m. EST/EDST no later than the 5th of the following month if that date is on a Friday; otherwise the release date will be the nearest Friday before the 5th. **The release time and release dates may differ from this schedule due to the timing of some holidays.** Due to the 4th of July holiday, the release date and time for the June Class and Component Prices is Thursday, July 3 at 2:00 p.m. EDST. The release time for the December Class and Component Prices on Friday, January 2, 2009, is 2:00 p.m. EST due to a holiday on the preceding day.

Payment Date Rules

Announcement of Statistical Uniform Price and Producer Price Differential (PPD)
Section 1001.62

On or before the 14th day after the end of the month. If the 14th falls on a Saturday, Sunday, or national holiday, the Market Administrator may have up to two additional business days to announce the price.

Payment to the Producer Settlement Fund
Section 1001.71

Payments made to the producer-settlement fund must be in a manner that provides receipt of the fund by the Market Administrator no later than two days after the announcement of the statistical uniform price and PPD, unless the due date falls on a weekend or national holiday, then the payment can be delayed until the next business day.

Payment from the Producer Settlement Fund
Section 1001.72

Payments from the producer-settlement fund must be made no later than the day after the due date required for payment to the Market Administrator producer settlement fund, unless the day falls on a weekend or national holiday, then the payment can be delayed until the next business day.

Payments to Cooperatives
Section 1001.73(b)

One day before partial and final payment are due pursuant to Section 1001.73 (a), each handler shall pay a cooperative association for milk received.

Payments to Producers and Cooperatives
Section 1001.73(a)

Payment to producers for milk produced during the month must be received the following month no later than the day after the date the Market Administrator is required to make any payments out of the producer-settlement fund, unless the day falls on a weekend or national holiday then the payment can be delayed until the next business day.

Effective 12/10/07
