## NORTHEAST ORDER UNIFORM PRICE FOR JULY 2015

Erik F. Rasmussen, Market Administrator for the Northeast Federal Milk Marketing Order, has announced that the statistical uniform price (SUP) paid by milk dealers (handlers) regulated under the Northeast Order during July 2015 is \$16.91 per hundredweight (\$1.45 per gallon) for milk delivered to plants located in Suffolk County, MA (Boston). The producer price differential (PPD) portion of the SUP for July is \$0.58 per hundredweight for milk delivered to plants located in Suffolk County, MA. The PPD (\$0.58) combined with the corresponding month's Class III price (\$16.33) equals the SUP (\$16.91).

The SUP represents a benchmark minimum price paid to dairy farmers, prior to allowable deductions, for farm milk containing of 3.5 percent butterfat, 2.99 percent protein, and 5.69 percent other solids. The actual price received by an individual dairy farmer will vary as the composition of a farm's milk differs from the component benchmarks. The PPD represents each producer's share of the value generated by the marketwide pool. The PPD is added to the payment producers receive for their milk's components and is adjusted for the location of the receiving plant(s). The SUP and PPD decrease by scheduled amounts the further away the plant(s) receiving the producers' milk are from Suffolk County, MA (Boston). \*

The Class prices for milk pooled in July are as follows: Class I, \$19.78 (Suffolk County, MA); Class II, \$14.70; Class III, \$16.33; and Class IV, \$13.15. Comparable prices for July 2014 were: Class I \$26.27, Class II \$24.41, Class III \$21.60, and Class IV price \$23.78. The component values for July 2015 are protein, \$2.6070 per pound; butterfat, \$2.1125 per pound; other solids, \$0.2004 per pound; and nonfat solids, \$0.6621 per pound.

Milk receipts from producers totaled 2.272 billion pounds. Class I utilization, milk processed as beverage milk, was 31.3 percent of producer milk receipts. The Class I utilization was 32.6 percent in July 2014.

The manufacture of Class II products such as cream, ice cream, yogurt, and cottage cheese utilized 25.4 percent of producer milk. Milk used to manufacture Class III products such as cheese (American and Italian) and evaporated and condensed products utilized 24.3 percent of total milk receipts. Class IV usage (butter, nonfat and whole milk powder) equaled 19.0 percent of the total.
