

## Summary

This *Bulletin* provides information about the operation of the Northeast Order during 2010 through a series of tables and charts. The *Bulletin Highlights* section summarizes important events that impacted the dairy industry in 2010. Included are lists of handlers and cooperatives operating under the Order with their respective locations depicted on a map of the region.

### **Producer Milk Receipts Increase**

During 2010, the volume of milk received from producers shipping to handlers regulated under the Northeast Order totaled 24.3 billion pounds, an increase of 3.6 percent from 2009. The increase was due to a combination of factors such as milk production growth in the region, higher prices, and pooling changes.

The year ended with 215 fewer producers than at the end of 2009. Annual average daily deliveries per producer (DDP) equaled 4,965 pounds—an increase of 3.2 percent from 2009 and a new record for the Order.

### **Class Utilization Changes**

In April 2010, a large volume Class I distributing plant became pooled on the Northeast Order, as a result of changes in the plant's route disposition, bringing with it a large amount of milk and producers from other states. This plant formerly had been pooled on a neighboring federal order.

Class I utilization averaged 42.7 percent in 2009, a decrease of 1.0 percentage point from the previous year. The total volume of milk used in Class I actually rose 1.2 percent but due to the corresponding increase in total milk pooled on the Order, the utilization percent decreased. Class II usage jumped 9.1 percent, resulting in an increase in utilization of 1.1 percentage points. Class II utilization averaged 21.3 percent. The growth in Greek-style yogurt largely was the driving force behind the substantial increase in the Class II volume.

Class III volume grew 7.6 percent with an increase in utilization of 1.0 percentage point and averaged 24.5 percent for 2010. The amount of milk used in Class IV dropped 4.6 percent and the corresponding utilization declined 1.0 percentage point. Class IV utilization accounted for an annual average of 11.6 percent.

### **Fluid Sales Decrease; Organic Grows**

Overall, sales of fluid milk products in the Northeast Milk Marketing Area declined 1.1 percent in 2010. Decreases were reported in whole, reduced-fat (2%), flavored fat-reduced, and buttermilk (includes eggnog, yogurt drink, and other miscellaneous products). Low fat (1%) and fat-free (skim) showed slight increases. Flavored whole milk increased 12.8 percent, but overall, this category only accounts for 0.2 percent of total sales in the marketing area.

Organic whole milk sales jumped 20.1 percent from

2009, while organic fat-reduced milk (includes reduced fat, low fat, fat-free, and lower-fat flavored products) grew 8.5 percent.

### **Prices Higher**

Commodity prices began rising during the last quarter of 2009 and continued through most of 2010. Both butter and dry whey had the second highest annual averages since the Order's inception. Correspondingly, component and class prices rose.

The Class I price averaged \$18.60 per hundredweight in 2010, \$3.87 (26.3 percent) above the 2009 annual average. The Class II price averaged \$16.02 per hundredweight, \$4.76 per hundredweight and 42.2 percent higher than the previous year. The Class III price averaged \$14.41, up \$3.05 and 26.8 percent over 2009. The Class IV price rose \$4.20, an increase of 38.6 percent, and averaged \$15.09 per hundredweight.

Overall, the statistical uniform price (blend) reported at Suffolk County, Massachusetts (Boston) averaged \$16.92 per hundredweight, \$3.91 (30.1 percent) higher than the 2009 price, and the third highest blend price on record for the Order. Compared to previous years, 2010 class prices were: Class I and II, third highest; Class III, fourth highest; and Class IV, second highest, since the Order's inception. The producer price differential (PPD) averaged \$2.51 per hundredweight in 2010, 86 cents higher than the average in 2009.

### **Component Pricing**

The price paid to producers for butterfat averaged \$1.8535 per pound, 47.4 percent higher than in 2009. The per-pound annual average protein price was \$2.3091 per pound, up 4.5 percent from 2009. The other solids price increased 190.4 percent and averaged \$0.1777 per pound. No negative other solids values were reported during 2010, compared to 4 months of 2009. The nonfat solids price rose 32.7 percent and averaged \$0.9909 per pound.


### **Producer Tests**

The annual average producer butterfat test equaled 3.70 percent in 2010, a drop of 2 percentage points from the previous year. The only record-setting month was December, which not only set a record for that month, but was the highest butterfat test ever for the Order. The annual average producer protein test was 3.05 percent, down 1 percentage point from 2009. Record highs were set during the months of November and December, and tied with the January high. The annual average producer other solids test increased 3 percentage points to 5.72 percent, setting a new record high annual average. Record highs also were set in the months of August through November 2010.





**3 Class III Prices, 2006–2010**



















## Bulletin Highlights —2010

### **January**

Statistical changes in the Northeast Order over the past ten years were summarized and discussed. A table compared Northeast Order selected statistics for 2000 and 2009. A chart illustrated the Northeast Order statistical uniform price for January 2000 through December 2009.

Sales of Class I fluid milk products for 2009 in the Northeast Milk Marketing Area totaled 8.8 billion pounds, a decrease of 1.4 percent from 2008. Volume and percent change information for 2008 and 2009 were shown in a table along with per capita sales data.

The market service department checked 426 farm bulk tanks throughout the Northeast Marketing Area milkshed during the 2009 season. An accompanying table illustrated the 2009 tank calibrations work by tank size.

### **February**

USDA released a final decision to amend the producer-handler definition in all federal milk marketing orders.

Milk price projections based on the Chicago Mercantile Exchange (CME) were discussed for 2010. Accompanying charts illustrated total natural cheese stocks for January 2007 through 2010, and total nonfat dry milk stocks for 2007 through 2009.

U.S. Milk production declined a slight 0.1 percent in 2009, when compared to leap year adjusted production in 2008. A table ranked the top ten states by 2009 production.

### **March**

A discussion emphasized how larger farms are playing a bigger role on the Northeast Order. A table showed farms by pounds pooled on the order for December 2000 and 2009, along with a map illustrating counties with farms pooling more than 600,000 pounds on the order for December 2009.

The results of the November 2009 biennial container sales survey for the Northeast Milk Marketing Area were reported. Charts illustrated sales by container size and product type.

A pool summary for all federal orders was given in a table for January–March, 2009 and 2010.

### **April**

USDA issued a final rule amending the producer-handler definition in all federal milk marketing orders.

The market situation was updated and discussed. Even though the uniform price was \$3.00 to \$4.00 per hundredweight higher than a year ago, it failed to reach levels predicted at the end of 2009. The Class IV price was predicted to be the Class I mover for the remainder of 2010. A chart illustrated block Cheddar, butter, and nonfat dry milk weekly commodity prices on the CME from January 2010 through May 2010.

USDA released their *Dairy Products 2009 Summary*, a publication reporting dairy products manufactured in the United States.

The component value portion of the uniform price, not including the producer price differential, under the Northeast Order for January 2010 was compared by county. A map illustrated average component values by county under the order for January 2010.

### **May**

USDA issued a final decision to amend the fluid milk product definition in all federal milk marketing orders; a referendum was underway.

For the first 6 months of 2010, the advanced Class IV skim milk pricing factor had been used to set the base skim milk price for Class I. Commodity stock trends were discussed and shown in charts illustrating cheese, butter, and nonfat dry milk stocks versus National Agricultural Statistics Service (NASS) prices for May 2009 through May 2010.

The total volume of Class I sales in the Northeast Milk Marketing Area by handlers not designated as pool distributing plants increased by 25.0 percent from 2008 to 2009 and 82.3 percent over the past 5 years. A table showed the sales in the marketing area by handler type for 2004, 2008, and 2009.

The Northeast Milk Marketing Area announced the tentative calibration truck schedule for 2010.

### **June**

The correlation between butterfat and protein percentages and milk production were discussed and accompanied by charts showing butterfat test versus pool receipts per day for January 2004 through June 2005, and January 2009 through June 2010.

The U.S. Dairy Export Council reported that export value had more than doubled to \$357.4 million in May 2010 compared to May 2009. Increases in dairy exports were highlighted.

Changes in utilization of Class I, II, III, and IV milk products and cream by pool plants under the

Northeast Order were discussed. An accompanying table showed utilization for selected products for January through June, 2010 versus 2009 and 2005.

A pool summary for all federal orders was given in a table for January–June, 2009 and 2010.

### **July**

Projections made at the Northeast Regional Dairy Outlook Conference in November 2009 were reviewed and compared to actual prices for the first six months of 2010. A mid-year price outlook was discussed and accompanied by a chart showing actual and estimated Northeast Order uniform prices for November 2009 through December 2010.

Milk production in the United States and milk pooled on the Northeast Order during the first 6 months of 2010 were compared to the same period in 2009. A table showed the top ten states ranked by milk production and Northeast Order pooled receipts for January through June 2010.

Changes in utilization in the Northeast Order outlined in the June *Bulletin* were compared to changes in specific products in the NASS monthly *Dairy Products* publication.

### **August**

USDA issued a final rule amending the definition of Class I fluid milk products in all federal milk marketing orders effective January 1, 2011.

The contribution to the producer blend price by components was discussed and accompanied by a table showing the contribution by component for the month of August for 2007 through 2010.

The amount of supplemental milk shipments by handlers regulated under the Northeast Order to southern orders was more than double the amounts during the past 2 years. A table showed bulk milk shipments and receipts from other federal orders for the month of August, 2006 through 2010.

The seasonality of milk production under the Northeast Order was reviewed and discussed. A chart showed average daily producer receipts per month on the order for each year since 2000.

### **September**

The USDA requested fluid milk processors and other interested parties to nominate candidates for the National Fluid Milk Processor Promotion Board.

Verified payroll data of producers whose milk was pooled on the Northeast Order for every month from January 2000 to December 2009 was analyzed to examine changes in producer milk production.

Accompanying charts showed distribution of farms in growth categories; changes in average daily volume over 10 years, by size category; and year-over-year change in volume of pooled milk, by farm size category.

### **October**

It was estimated that 2010 will finish with a single Milk Income Loss Contract Payment (MILC) in April; 2009 had 10 months of payments. MILC payments for 2011 were projected for all months using CME futures prices for milk and feed.

With improvements in transportation, processor mergers, and plant closures, fluid milk products are transported greater distances and the remaining plants in the Northeast now service larger geographical areas. A map illustrated the location of distributing and supply plants under the Northeast Order and compared producer milk by class of use and location differential for September, 2001 and 2010.

A pool summary for all federal orders was given in a table for January–September, 2009 and 2010.

### **November**

The fluid milk product definition final rule approved in a referendum in June 2010 would become effective January 1, 2011.

The 2010 Northeast Regional Dairy Outlook Conference was held on November 18 at the Northeast Order's Albany office. A table showed the statistical uniform prices for 2009, the actual and estimated prices for 2010, and the estimated prices for 2011.

Commodity Credit Corporation (CCC) purchases were negligible for marketing year (MY) 2010; only 132,276 pounds of nonfat dry milk were purchased. A table showed CCC purchases of dairy products under the support program for MY 1990 through MY 2010.

A calendar showed the 2011 dates for partial payments to producers who are not members of cooperatives. The Order requirement was explained.

### **December**

Selected Northeast Order statistics for 2010 were summarized, and a table compared the Order's pool statistics for 2009 and 2010.

Using CME futures prices of Class III and IV milk, strong milk prices were projected for 2011 for the Northeast Order, along with high feed prices. Commodity price levels, along with feed futures prices, were discussed.

A pool summary for all federal orders was given in a table for January–December, 2009 and 2010.
