

Summary

This bulletin provides information about the operation of the Northeast Order during 2016 through a series of tables and charts. The *Bulletin Highlights* section summarizes events that impacted the dairy industry in 2016. Included are lists of handlers and cooperatives operating under the Order with their respective locations depicted on a map of the region.

Record-setting Producer Milk Volume

Pool volume has been strong for the past three years, but the volume of milk received from producers shipping to handlers regulated under the Northeast Order during 2016 set a new record high for the Order, topping 27 billion pounds for the first time ever. On a percentage basis, total Northeast Order milk receipts in 2016 were 3.4 percent higher than in 2015. Nationally, milk production rose 1.6 percent in 2016. The states of New York, Pennsylvania, and Vermont (the Order's largest contributing states) had a combined increase of 2.8 percent in production. All changes have been adjusted for leap year in 2016.

The year ended with 384 less producers than at the end of 2015. Annual average daily deliveries per producer (DDP) equaled 6,440 pounds, an increase of 6.1 percent from 2015, and a new Order record.

Class Utilization Changes

Class I utilization averaged 32.7 percent in 2016, a decrease of 1.6 percentage points from the previous year. The total volume of milk used in Class I continued its decline, but at a slower rate than in 2015. During 4 months of 2016, Class I volume surpassed the same month of the previous year. Class II usage increased 3.4 percent and was only 27 million pounds below the record-setting total in 2013. Overall, utilization was 24.3 percent, the same percent as in 2015, but based on a larger total volume.

Class III volume jumped 10.2 percent and ended the year with the second largest total since the Order's inception, surpassed only by the volume in 2000. Utilization averaged 25.4 percent, up 1.5 percentage points from 2015. The amount of milk used in Class IV rose for the fifth straight year, setting a new record high. It accounted for an annual average of 17.6 percent utilization, up slightly from 2015.

Lower Prices

Plentiful supplies of milk, coupled with softness in demand, impacted market prices and resulted in the lowest average producer prices since 2009.

Commodity Prices—Butterfat demand was strong

due to increased interest in higher fat products that began in 2015. As a result, butter was the only National Dairy Products Sales Report (NDPSR) product to experience an increase, albeit slight, in price during 2016. Even so, the annual average was the second highest NDPSR butter price on record. During 2016, butter prices were less volatile than in 2015. Prices in 2016 peaked at \$2.3675 in June (compared to \$3.1350 in September 2015) but never fell below October's \$1.7550 per pound (compared to January 2015's \$1.5400). Cheese prices followed a similar pattern as in 2015, although they bottomed out lower and peaked higher. Overall they averaged about 4 cents per pound less than in 2015. Both nonfat dry milk and dry whey prices continued to climb throughout 2016, but averaged less than 2015.

Component Prices—All annual average component prices were below the previous year except butterfat, which was up slightly. Lower component prices translated into lower class prices, and ultimately, lower statistical uniform prices. The price paid to producers for butterfat averaged \$2.3084 per pound, up slightly from 2015 and the second highest reported since the Order's inception in 2000. The per-pound annual average protein price was \$2.0955 per pound, the lowest since 2006, and a decline of 6.4 percent from 2015. The other solids price averaged \$0.0910 per pound, the lowest in 7 years. The nonfat solids price averaged \$0.6548 per pound, the lowest since the Order's inception.

Class Prices—The Class I price averaged \$18.05 per hundredweight in 2016, a drop of 7.9 percent from the 2015 annual average. The Class II price averaged \$14.35 per hundredweight, down 7.3 percent from the previous year. The Class III price averaged \$14.87, down 5.9 percent from 2015. The Class IV price dropped to \$13.77, a decrease of 4.0 percent. Overall, the statistical uniform price (blend) reported at Suffolk County, Massachusetts (Boston) averaged \$15.90 per hundredweight, 7.2 percent below the 2015 average. All class and uniform prices were their lowest in the past 6 or 7 years.


Producer Tests

The annual average producer butterfat test equaled 3.81 percent in 2016, up 0.03 points from the previous year, setting a new Order record high. The annual average producer protein test was 3.09 percent, up 0.02 points from 2015 and also a new record for the Order. The producer other solids test averaged 5.75 percent, unchanged from the previous year and tied as a record with 2012 and 2015.



2 Class II Prices, 2012–2016











Figure 6**Figure 7**



9 Receipts of Milk from Producers, by State*, 2016













Bulletin Highlights — 2016

January

A summary of the 2015 market service program was discussed. An overview of the calibration program was given as were the results of tank checks/calibrations. A chart illustrated tank checks and calibrations by tank size for 2015. A table announced the tentative calibration truck schedule for 2016.

A significant volume of milk was depooled from federal orders because of disadvantageous price relationships in 2015. A comparison of federal orders, along with the Northeast Order compared to all orders, was discussed.

A pool summary for all federal orders was given in a table for January–December, 2014 and 2015.

February

The total U.S. milk production increased 1.3 percent in 2015. Milk production in the Northeast milkshed increased 1.6 percent in 2015, greater than both the U.S. and the top 23 averages. Nationally, the number of milk cows increased 0.6 percent; Northeast milkshed states declined a slight 0.1 percent. Average milk production per cow (MPC) grew 0.6 percent nationally and 1.6 percent in the Northeast. A table showed the top ten states ranked by milk production for 2015.

The USDA's Economic Research Service released a report titled "Changing Structure, Financial Risks, and Government Policy for the U.S. Dairy Industry." The report claimed dairy farming has changed dramatically with cows and production shifting to much larger operations. A table compared Northeast Order pooled pounds and producers by farm size category for December, 2006 and 2015.

March

The trend continued in the Northeast Marketing Area with the decline of Class I utilization continuing to set lows and the growth in Class IV utilization continuing to establish new highs, in both volume and percent. A discussion was held on the Northeast class utilization trends and its proportion of all Federal Order milk. A chart illustrated the Northeast pool volume as a proportion of all Federal Order areas' combined pool volumes from 2011 through 2015.

The results of the November 2015 biennial container sales survey for the Northeast Milk Marketing Area were reported. A chart illustrated sales by container size for November 2015.

April

Component levels by production size for 2015 were analyzed and discussed. A table showed proportion of pool volumes and producers and average component tests by production size for 2015.

For the first time the April statistical uniform price was higher than the March price even though all class prices were lower. A table showed the comparison of the calculation of the Producer Price Differential for March and April, 2016.

The volume of milk pooled on the Order during April 2016 was the largest for the month of April and nearly 9 percent greater than the average for the first 16 years of the Order. Class IV milk under the usage category "animal feed and dumpage" jumped to 22.6 million pounds. The dumping of surplus of milk during this month was discussed.

A pool summary for all federal orders was given in a table for January–March, 2015 and 2016.

May

The USDA's National Agricultural Statistics Service released their *Dairy Products 2015 Summary*. Changes in national cheese production, other products, and percent of total milk production were compared to the Northeast Order. The leading cheese producing states were discussed. A table highlighted selected products' changes from 2014 and 2010, and a comparison of Northeast Order milk used in the manufacture of these products in 2015.

A market situation update reported the statistical uniform price (SUP) at the Boston, MA, zone average for January through May 2016, and a projected average for 2016 using the Chicago Mercantile Exchange's (CME) Class III and Class IV milk future prices. U.S. volume and value of exports along with other demand factors and the supply side were analyzed. A chart illustrated actual and projected Northeast Order uniform prices at the Boston, MA, zone from 2015 through 2016.

June

Total sales of fluid milk products have declined in the Northeast consistently since 2010, but when broken down by sales category, higher fat products are on the rise. Accompanying tables showed 1) the sales of fluid milk products and 2) average butterfat tests and proportion of fluid milk products sold in the Northeast Marketing Area for the first six months of 2010, 2012, 2015, and 2016.

A discussion covered the milk marketing

environment that included robust milk production, less demand for Class I, regional balancing plants operating at capacity, and unfavorable economics of moving milk to facilities outside of the Northeast that resulted in some handlers dumping excess milk.

A pool summary for all federal orders was given in a table for January–June, 2015 and 2016.

July

For the fourth consecutive year, the shipping percentage was reduced from 20 to 15 percent for the months of September, October, and November, for both 2016 and 2017.

The total pooled milk volume for the Northeast Order for the first 6 months of 2016 was 4.4 percent higher than the same period last year. A table showed actual and projected Northeast Order total pool milk volume from January 2012 through December 2016.

National milk production, Northeast pool volumes, and contributions by county in the Northeast were discussed. Maps presented year-to-year percent change in U.S. milk production for select states and milk pooled by county in the Northeast Order from January through May 2016.

August

The total volume of producer milk pooled on the Northeast surpassed the 2015 figures for each month for the past 10 months in a row. Class I volume has continued to decline, but Class II, III, and IV volumes were all above the same month previous year for the past 12 months. A chart showed Northeast Order percent of utilization by class for selected prior years and August 2016.

Negative Producer Price Differentials (PPD) occurred in outer zones of the Northeast Order. An explanation of why producers would receive negative PPDs was given. A chart illustrated actual and projected prices of the SUP at the Boston zone, the Class III milk price, and the *National Dairy Products Sales Report* weighted average cheese price for 2016.

September

A market situation update showed the use of the CME Class III and Class IV milk futures prices projected the SUP to average \$17.90 per cwt at the Boston, MA, differential zone for 2016. Accompanying charts displayed 1) the actual and projected uniform price at Boston, MA, and 2) the actual and projected Northeast SUP and class prices for 2016.

The decline of seasonal bulk shipments of milk

between the Northeast Order and the Southeast during August and September was discussed. A table showed shipments of milk by regulated handlers to and from the Northeast Order for the combined months of August and September, 2006 and 2016.

A pool summary for all federal orders was given in a table for January–September, 2015 and 2016.

October

The PPD for October 2016 was \$1.41 per cwt at Boston, MA, differential zone, but a negative PPD was expected for November. A chart illustrated the relationship between the Class III milk price; SUP at Suffolk County, MA; and PPD prices, actual and projected, for 2016 through 2017.

The utilization of milk products and cream by pool plants within the Northeast Order for the first 10 months of 2016 was compared to 2015. The total volume of milk assigned to the Minimum Price Class jumped 79.5 percent when compared to last year. Details of class utilizations for the Northeast were discussed.

Handlers regulated under the Northeast Order requested authorization for pooling of milk disposed of or dumped to retain the status of pooled producer milk during the 2016 Thanksgiving through New Year's holiday period.

November

The Northeast Order uniform price was forecast for 2016 and 2017. Demand and supply factors were analyzed for 2016 and predicted for 2017.

November 2016 had a negative PPD in all differential zones; however, the SUP of \$16.34 per cwt was higher than October's signifying a negative PPD does not necessarily reflect a lower price for producers.

A calendar showed the 2017 dates for partial payments to producers who are not members of cooperatives. The Order requirement was explained.

December

Selected Northeast Order statistics for 2016 were summarized, and a table compared the Order's pool statistics for 2015 and 2016.

December was expected to be the last month for negative PPDs in differential zones below \$3.00. Negative PPDs were explained and current PPD dynamics were discussed. Price projections for 2017 based on CME future prices of Class III and Class IV milk predicted Northeast Order positive PPDs from January through June 2017.

A pool summary for all federal orders was given in a table for January–December, 2015 and 2016.
