

Summary

This bulletin provides information about the operation of the Northeast Order during 2022 through a series of tables and charts. The *Bulletin Highlights* section summarizes important events that impacted the dairy industry in 2022. Also included are lists of handlers and cooperatives operating under the Order with their respective locations depicted on a map of the region.

Order Volume Decreases Slightly

Total milk received from producers equaled 26.9 billion pounds in 2022, down 0.6 percent from 2021. The annual average volume per producer grew 445 pounds from the previous year and topped 9,000 pounds for 4 months during 2022. The year ended with 8,084 producers, a drop of 665 from December 2021. Comparisons have not been adjusted for any milk that was not included in the pool (depooling).

Class Utilization Changes

Class I utilization averaged 29.6 percent in 2022, down 0.5 percentage points from 2021. The volume of milk used for Class I purposes declined 175.7 million pounds (2.2 percent) from the previous year, compared to only (0.9 percent) in 2021. The total volume of producer receipts used in Class II decreased 396 million pounds (5.8 percent), following a record high usage in 2021. The Class II utilization percentage fell 1.3 percentage points to 23.8 percent of total producer milk pooled in 2022.

Class III volume jumped 9.7 percent (691 million pounds) and utilization averaged 29.0 percent, up 2.7 percentage points from 2021. This increase was due to a combination of more milk used in cheese (American, Italian, Swiss and other hard varieties and cream cheese) and the milk assigned to the lowest class price (shrinkage, dumped, animal feed, lost in transit) as the Class III price was the lowest for all but one month of 2022. The amount of milk used in Class IV decreased 5.7 percent and accounted for an annual average of 17.6 percent utilization, a decrease of 0.9 percentage points.

Most Prices Higher Than 2021

Prices started out strong at the beginning of the year, continued to rise, and peaked in June 2022. Even though prices subsided somewhat in the second half of the year, at \$24.96, 2022 finished with the highest average Statistical Uniform Price (SUP) since the Order's inception, topping the second-highest year, 2014, by 68 cents per hundredweight (cwt).

Commodity Prices—National Dairy Product Sales Report (NDPSR) butter prices jumped 65.5 percent from 2021 and averaged \$2.8665 per pound, the highest on record since federal order reform. NDPSR cheese prices averaged \$2.1122 per pound, an increase of 26.1 percent with combined averages of \$2.1011 for blocks and \$2.0918 for barrels, increases of 21.4 and 31.1 percent, respectively.

The NDPSR nonfat dry milk price increased 32.8 percent from 2021, averaging \$1.6851 per pound. Dry whey prices were up 5.5 percent from the previous year and averaged \$0.6057 per pound.

Component Prices—All component price averages were above the previous year except protein. The price paid to producers for butterfat averaged \$3.2637 per pound, up 72.6 percent from 2021 and a record high since federal order reform and the first time the annual average was greater than \$3.00 per pound. The annual average protein price was \$2.7238 per pound, down 1.4 percent from the previous year's average. The other solids price averaged \$0.4188 per pound, an increase of 8.3 percent from 2021. The nonfat solids price averaged \$1.5021 per pound, an increase of 37.7 percent from the previous year.

Class Prices—Annual average class prices were significantly higher than in 2021. The Class I price averaged \$26.91 per hundredweight in 2022, up 34.0 percent from the 2021 annual average. The Class II price averaged \$25.27 per hundredweight, an increase of 53.7 percent from the previous year. The Class III price averaged \$21.96, 28.6 percent above 2021. The Class IV price averaged \$24.47, an increase of 52.1 percent. Overall, the statistical uniform price (blend) reported at Suffolk County, Massachusetts (Boston) averaged a record-high \$24.96 per hundredweight, 39.6 percent above the 2021 average. The producer price differential (PPD) averaged \$3.00 per hundredweight (at Boston) for the year, the second highest annual average since the Order's inception.

Producer Tests


The annual average producer butterfat test equaled 4.03 percent in 2022, an increase of 0.04 percentage points from 2021. A new Order high was set in December at 4.18 percent. The annual average producer protein test was 3.16 percent, up 0.01 percentage point from the previous year. A new Order high was set in December at 3.26 percent. The producer other solids test averaged 5.78 percent, an increase of 0.01 percentage point.



2 Class II Prices, 2018–2022



3 Class III Prices, 2018–2022












9 Receipts of Milk from Producers, by State*, 2022















Bulletin Highlights — 2022

January

A discussion was held on the U.S. Bureau of Labor Statistics' (USBLS) *Consumer Expenditure Survey* (CES) results in the U.S. and Northeast that focused on the food at home and dairy categories. Charts illustrated average annual consumer household dairy product, fresh milk, and cream expenditures by region, and dairy products as a portion of food at home expenditures from 2000 through 2020.

February

U.S. milk total production rose 1.6 percent in 2021; for comparison, growth in 2020 was at a six year high at 1.9 percent. Milk production, cow numbers, and production per cow were compared for the U.S. and Northeast milkshed for 2021 vs 2020. A table showed selected statistics for the top ten states ranked by 2021 milk production.

The 2021 market service program was summarized. An overview of the calibration program was given, as were the results of tank checks/calibrations. A chart illustrated tank checks and calibrations by tank size for 2021.

March

Changes in rankings and the proportion of farms and daily deliveries per producer (DDP) in the top ten Northeast Order counties in 2021 were discussed. A map depicted the top ten counties: their rank and percent change in pounds, farm numbers, and DDP from 2020 to 2021. A table showed milk production, number of farms, and average DDP in the top ten counties pooling on the Order for 2021.

A table announced the tentative calibration truck schedule for 2022.

Pool data for all federal orders was summarized in a table for January–March, 2021 and 2022.

April

The results of the November 2021 biennial container sales survey for the Northeast Milk Marketing Area were reported. A table compared packaged fluid milk products by method of distribution in 2021 to 2019. A chart illustrated sales by container size for November 2021.

Using Chicago Mercantile Exchange (CME) futures prices of Class III and IV milk and

estimates of Northeast Order class utilizations, the statistical uniform price (SUP) at the Boston, MA, locations projects 2022 to average \$25.16 per hundredweight (cwt) with an average producer price differential (PPD) of \$1.98 per cwt. Feed prices, dairy exports, and inflation were discussed. A chart illustrated feed prices and SUP for January 2012 through December 2022 along with projected April through December 2022.

May

The United States Department of Agriculture's (USDA) National Agricultural Statistics Service (NASS) released their *Dairy Products 2021 Summary*. Changes in national cheese production and other selected products, top manufacturing states, and percent of total milk production were discussed. A table highlighted selected products' changes from 2020 and 2016 to 2021, and a comparison of Northeast Order milk used in the manufacture of these products.

A discussion was held on the relationship between the household dynamic and dairy product expenditures over a 20-year period, 2001 through 2020, using the USBLS' CES. A chart displayed dairy product as a portion of consumer unit food expenditures for 2001 through 2020.

June

Milk production in the U.S. for the first 6 months of 2022 was compared to the same period in 2021. A table showed the top ten states ranked by milk production and selected areas for 2021 vs 2022. A map illustrated the year-to-year percent change in milk production for the NASS 24 major states for January through June 2022. Northeast Order pool volume was discussed.

The Market Administrator approved lowering the shipping percentage for September through November for years 2022 and 2023. An explanation of a request and decision on lowering the percentage of milk that pool supply plants and cooperative Section 1000.9(c) handlers must deliver to Class I pool distributing plants for the months of September, October, and November for the Northeast Order was given.

Pool data for all federal orders was summarized in a table for January–June, 2021 and 2022.

Bulletin Highlights — 2022 (*continued*)

July

A discussion was held on the USBLS CES results focused on Consumer Unit (CU) spending on dairy products in relation to age of the Reference Person (RP) in the U.S. between 2000 and 2020. Comparisons of expenditures by age, fresh milk and cream, other dairy, and trends were highlighted.

The SUPs for the months of April through July 2022 were 4 of the top 5 highest in the past 22 years. Using CME futures prices of Class III and IV milk and estimates of class utilizations, the SUP at the Boston, MA, location projects to average \$24.69 per cwt for 2022. Impacts of feed prices, dairy exports, fuel, and inflation were discussed. A chart compared and projected SUP versus corn, soybean, and diesel prices for 2022.

August

The PPD for August 2022 for the Northeast Order set a record high at \$5.32 per cwt at the Boston, MA, location. An overview of high and low PPDs was given.

A discussion was held on the USBLS CES results focused on CU spending on dairy products in relation to race and Hispanic/Latino origin of the RP in the U.S. between 2003 and 2021. Comparisons of expenditures by race and Hispanic or Latino origin were highlighted. A chart illustrated dairy product expenditures, adjusted for inflation, by race from 2003 through 2021.

September

NASS reported in their monthly *Agricultural Prices* publication for August 2022 that alfalfa hay has increased the most since the beginning of the year for a 30.3 percent increase to \$64 per ton. NASS feed prices and Dairy Margin Coverage (DMC) program payments were discussed. Charts illustrated feed prices from January 2012 through August 2022 and DMC prices from January through August 2022.

Relationships between farm size and component tests using certified payroll data for producers pooled on the Order were discussed. Average butterfat and protein tests by farm size were illustrated in charts comparing 2012, 2016, and 2021.

Pool data for all federal orders was summarized in a table for January–September, 2021 and 2022.

October

An explanation of what contributes to producers' milk checks was given. A table showed Northeast Order contributions by components for September and October 2022. A chart displayed Northeast Order contribution by components to SUP for selected months.

An overview of the recent price of butter and how it may affect prices in future months was given. Aspects of the current butter market, butter price relationships were reviewed along with a discussion on butter price impacts on the PPD and SUP. A chart illustrated average monthly butter price and PPD for January 2017 through October 2022.

November

Cost, demand, and supply factors were analyzed for 2022 and predicted for 2023. A chart displayed the actual and estimated SUP compared to corn, soybean, and diesel prices for 2019 through projected 2023.

A schedule showed the 2023 dates for partial payments to producers who are not members of cooperatives. The Order requirement was explained.

USDA's Farm Service Agency announced the extension of enrollment and coverage election period for 2023 DMC to January 31, 2023.

December

Northeast Order's total milk received from producers in 2022 decreased 0.6 percent from 2021. Even though prices subsided somewhat in the second half of the year, 2022 finished with the highest average SUP since the Order's inception. Selected Northeast Order statistics for 2022 were summarized, and a table compared the Order's pool statistics for 2021 and 2022. A chart illustrated the class utilization of milk pooled on the Order for 2013 through 2022.

Pool data for all federal orders was summarized in a table for January–December, 2021 and 2022.
